2. Chairperson's Business

2.1 Committee Membership

3. Northern Ireland Teachers' Pension Scheme (NITPS) – draft statutory rule – Departmental Briefing

Departmental officials joined the meeting at 2.06pm.

La'Verne Montgomery, Director of Education Workforce Development; and Seamus Gallagher, Pay Remit and Pensions Policy Team briefed the Committee on the proposed rule: The Teachers' Pension Scheme Regulations (Northern Ireland) 2014.

The briefing was followed by a question and answer session.

Agreed: The Committee agreed to write to the Department indicating that it was content for the rule to be made on the understanding that the Department will be flexible in respect of the timelines etc. for key pension decisions by NITPS members and that it will review the need for flexibility in this regard on an on-going basis.

Agreed: The Committee also agreed to write to the Department indicating that it expects a substantial improvement in the near future to the collection and maintenance of equality data for the teaching workforce in order to ensure that the equality impact of this and other policies can be accurately assessed.

4. January Monitoring Round – Departmental Briefing

The Departmental briefing on the January Monitoring Round was deferred.

5. Any Other Business

Agreed: The Committee agreed to write to the Department seeking clarification in respect of reported delays to planned Minor Works related to Health and Safety issues in a school as a consequence of the absence of an agreed local Area Plan.

Agreed: The Committee agreed to write to the Department seeking clarification on the inspection of youth provision; Education Other Than At School (EOTAS) and other alternative education providers.

Agreed: The Committee agreed to commission Assembly Research to provide background information on EOTAS and other alternative education providers.

6. Inquiry into the Education and Training Inspectorate and the School Improvement Process – Reply to Departmental response

The Committee considered its reply to the response from the Department of Education to the inquiry into the Education and Training Inspectorate and the School Improvement Process

Agreed: The Committee agreed to write to the Department:

- again highlighting concerns in respect of the Formal Intervention Process and inadequate resourcing of school improvement;
- seeking an update on "paired observation", changes to moderation practices, the introduction of a "running record" report, the replacement of 1-word descriptors in inspection reports and the development of the school dashboard;
- highlighting concerns in respect of the ETI Complaints Procedure and the effectiveness of post-school questionnaires;
- seeking clarity in respect of the inspection of Irish Medium provision; and
- recording its disappointment that the Department is not to: bring into effect a parental consultation platform or commission ETI to undertake longitudinal studies of the effectiveness of the education system.

Agreed: The Committee agreed to publish on its webpage its reply to the Departmental response to the inquiry.

The Committee will meet again on Wednesday 10 December 2014 at 10.00am in Methodist College, Belfast.
