# 2. Chairperson's Business

# **2.1 DEL International Review Panel of Initial Teacher Education Infrastructure**Members noted that the Deputy Chairperson had attended an informal meeting with members of the International Review Panel on the Structure of Initial Teacher Education (ITE) in Northern Ireland.
