# 2. Chairperson's Business

## 2.1 Nurture Units

The Chairperson advised of a recent Committee visit to the nurture units at Edenbrooke Primary School and St Patrick's Primary School. Members indicated that they were greatly impressed by the professionalism and positive attitude of the school principals and nurture unit staff. The Committee reaffirmed its interest in the review of the relevant Delivering Social Change Signature Project.

*Agreed:* The Committee agreed to write to both schools, commending them for their professionalism and thanking them for their hospitality.

## 4. Matters Arising

## 4.1 Northern Ireland Teachers' Pension Scheme

The Committee noted correspondence from the Department responding to Committee queries relating to proposed changes to the Northern Ireland Teachers' Pension Scheme (NITPS).

*Agreed:* The Committee agreed to forward the Departmental response to the teaching unions for their information.

*Agreed:* The Committee also agreed to forward relevant information to the Employment and Learning Committee.

**Agreed:** The Committee, as requested by the Department, agreed to schedule an additional meeting on Tuesday 9 December 2014 at 2.00pm to include a briefing on the NITPS and possibly on the January Monitoring Round.

## 5. 2015-16 Draft Budget - Departmental briefing

Departmental officials joined the meeting at 9.56am.

Trevor Connolly, Director of Finance; Gavin Patrick, Deputy Director of Finance, and Philip Irwin, Director of Investment and Infrastructure briefed the Committee on the Department's 2015-16 Draft Budget.

The Committee noted correspondence from Area Learning Partnerships in the South Eastern Education and Library Board area commenting on the 2015-16 Draft Budget and proposed reductions in funding for the Entitlement Framework.

The briefing was followed by a question and answer session.

Michelle McIlveen declared an interest as a member of the Boards of Governors of a number of schools.

Jonathan Craig declared an interest as a member of a Board of Governors of a school.

Agreed: The Committee agreed write to the Minister:

- indicating disappointment at the absence of information on the draft budget and the limited time allowed for scrutiny;
- recording concern both in respect of: the impact on teaching and nonteaching employment levels and also the proposed timelines for redundancy;
- noting the absence of information in respect of: PEDU recommendations relating to school catering and school transport; savings associated with the establishment of the Education Authority; and Welfare Reform penalties;
- calling for greater use of output measurements, benchmarks and evaluation of policies including the development of a revised Savings Delivery Plan; and
- given the wide-ranging impact of the proposed changes, inviting him to brief the Committee on the anticipated impact of the 2015-16 Budget.

Agreed: The Committee also agreed to write to the Department seeking:

- information on how the school meals nutritional standards obligation is to be met and measured;
- clarification as to whether the Sure Start programme is to be rolled out, as planned, from the 20% most deprived wards to the 25% most deprived wards;
- clarification as to how proposed reductions to support for the Entitlement Framework will impact on associated transport costs for pupils;
- clarification in respect of the references in the budget consultation document to Area-based Planning and the sustainability of schools;
- detail in respect of the budget reductions for 3<sup>rd</sup> party organisations and Non-Departmental Public Bodies; and
- an updated budget distribution table for 2015/16.

**Agreed:** The Committee agreed that the Clerk would draft and circulate for approval a response to the Committee for Finance and Personnel in respect of the 2015-16 Draft Budget.
