# 1. Area Planning – draft position paper

The Committee noted and discussed changes to the draft position paper on Area Planning.

**Agreed:** The Committee agreed to re-consider the amended paper at next week's meeting.

# 3. Chairperson's Business

#### 3.1 Early Years Allocations

The Chairperson advised Members that stage one of the pre-schools admission process had concluded and that although reportedly 95% of children had been placed, it was reported that some of the placements are not satisfactory.

**Agreed:** The Committee agreed to write to the Department seeking further information on Early Years allocations including the availability of places: in reasonable proximity to home addresses and for the children of working parents. The Committee also sought clarity on the reported allocation of children of non-Irish speaking parents to Irish Medium Education Early Years settings.

#### 3.2 Deaf Youth Forum

The Chairperson advised Members that the Deaf Youth Forum is to launch its manifesto on 18 May 2015.

**Agreed:** The Committee agreed to write to CCEA seeking information on a reported pilot Sign Language GCSE and plans (if any) to make this available throughout Northern Ireland.

# 3.3 Education and Training Inspectorate (ETI) and Development Proposals

The Chairperson referred Members to a recent written question wherein the Department indicated that ETI had 'not supported' a number of Development Proposals.

**Agreed:** The Committee agreed to write to the Department again seeking clarity as to ETI's involvement in the Development Proposal process.

#### 3.4 School Bus Safety

The Chairperson advised Members of a recent press article regarding the detection of safety non-compliances on Home to School transport.

**Agreed:** The Committee agreed to write to the Department seeking an update on the safety of Home to School transport and the relevant schedule of inspection.

#### 5.1 Special Educational Needs and Disability (SEND) BILL

# 6. Review of Sure Start - written briefing

The Committee considered the report on the Independent Review of the Sure Start Programme

**Agreed:** The Committee agreed to write to the Minister:

- seeking his views on the recommendations and a timescale for the conclusion of his deliberations:
- expressing concerns in respect of the complex governance structure for Sure Start and suggesting that consideration be given to simplification, in order to secure savings;
- seeking clarification as to whether consideration is being given to the better governance and improved delivery of programmes like Sure Start as part of the planned reorganisation of Departmental responsibilities; and
- highlighting the important role that Sure Start plays in overall Early Years provision and seeking clarification in this regard for the Early Years Fund.

**Agreed:** The Committee agreed to share the report with the Committee for Health, Social Services and Public Safety.

# 7. ETI evaluation: Special Educational Needs Early Years Identification Capacity Building Pilot – written briefing

The Committee considered the ETI evaluation of the Special Educational Needs (SEN) Identification Capacity Building pilot in Early Years settings.

**Agreed:** The Committee agreed to write to the Minister seeking: his views on the recommendations and the associated costs; and a timescale for implementation.

**Agreed:** The Committee also agreed to write to the Department seeking clarity on: references to a review of the practice of prioritising referrals in primary schools etc. and the transfer of SEN pupil records from primary to post-primary schools and post-primary schools to Further Education colleges.

#### 8. School Starting Age – Departmental Briefing

Officials joined the meeting at 11.07am.

David Hughes, Director of Curriculum, Qualifications and Standards, Department of Education; Dale Heaney, Head of Assessment and Qualifications Team, Department of Education; Heather Robinson, Head of Early Years (Pre-School) Team, Department of Education; and Florence McCaw, Transfer Officer, Education Authority briefed the Committee on the feedback from the consultation on flexibility in respect of school starting age.

**Agreed:** The Committee agreed to write to the Minister expressing its disappointment that this important issue is not to be the subject of legislative scrutiny in the current mandate.

- an update on the issuing of school starting age guidance; and
- information on the Departmental review of the Foundation Stage.

**Agreed:** The Committee agreed to write to the Minister seeking clarity on the relevant timescales and details of the legislative vehicle for the proposed changes.

**9.12** The Committee noted correspondence from the Northern Ireland Anti-Bullying Forum enclosing its NIABF 2013 report.

**Agreed:** The Committee agreed that it was content for the Chairperson to meet informally with the Northern Ireland Anti- Bullying Forum, diaries permitting.
