*The meeting commenced in closed session at 10:01am.*

**1. Assembly Legal Services – legal advice on compelling witnesses and documents**

The Committee noted legal advice on compelling witnesses and documents.

The Committee noted a briefing paper from Assembly Research on budget processes in the United Kingdom and the Republic of Ireland.

The Committee noted Departmental correspondence on scrutiny of the budget and the October Monitoring Round.

The Committee considered legal advice provided by Simon Kelly from Assembly Legal Services.

**Agreed:** The Committee agreed to write to the Department:

- requesting 2017-18 resource and 2017-21 capital budget information and a related oral briefing session as soon as possible (in closed session, if necessary) from Departmental officials;
- again seeking clarification as to why this information is not to be provided to the Committee, prior to the budget being laid in the Assembly; and
- Indicating that in the event of the information and briefing not being provided, the Committee may elect to seek to compel the Department to provide relevant documents and witnesses in line with the powers set out in Section 44(1) of the Northern Ireland Act 1998.

## **2. Committee Planning Session/ Forward Work Programme**

The Committee considered the commissioning of research papers and additional oral evidence sessions. The Committee also considered the subject of a formal Committee inquiry.

**Agreed:** The Committee agreed to commission research papers on:

- the content of the primary school curriculum and its links to the needs of the economy;
- the cost of education and the cost of empty school places;
- physical education in schools;
- underachievement and educational attainment;
- educational progress in composite classes;
- costs and options in respect of parental choice in education;
- special educational nursery provision; and
- educational practice in Finland and Germany.

**Agreed:** The Committee agreed to seek Departmental evidence sessions on:

- the tracking of pupil progress in schools;

- the Priorities for Youth policy and the role of volunteers in youth provision; and
- Alternative Education Providers.

**Agreed:** The Committee agreed that it would undertake an inquiry into educational underachievement and that the inquiry would include consideration of: underachievement for marginalised children; recommendations to remove barriers to achievement; and the impact of current post primary transfer arrangements.

**Agreed:** The Committee agreed to consider the terms of reference for the inquiry at a subsequent meeting.

**Agreed:** The Committee agreed that it was content to receive a further Departmental briefing on the Special Educational Needs regulations on 7 December 2016.

**Agreed:** The Committee agreed that it was content with its Forward Work Programme as amended.

that the Department supports the Fostering Network's Outcomes Seminar.

**Agreed:** The Committee agreed to write to the Fostering Network regarding its interaction with other fostering organisations including Foster Care Associates (FCA).

The Chairperson referred Members to the Education Authority's consultation document on Area Planning - 'Providing Pathways 2017-2020'.

**Agreed:** The Committee agreed to seek further details on individual Area Plans. The Committee also agreed that the Chairperson should write to the Minister seeking clarification on the planned consultation for Area Planning Action Plans and in respect of the Minister's intentions (if any) to reduce or eliminate the Small Schools Support Factor.
