The Committee was given presentations on:

• The transition process in the past and how it has changed.

- The current transition process for those with moderate learning difficulties and their transition to College.
- The current transition process for those with complex medical needs and their transition to day care centres.
- The current transition process for those with challenging behavioural issues.
- The impact on parents of the transition process.

Issues raised

- Lack of teacher involvement in the transition process.
- Uncertainty of whether a place will be provided post school little information for parents.
- Lack of investment in places.
- Lack of trained staff and additional support in Colleges and Day Care Centres.
- Lack of relevant subject options at colleges and no teacher input to developing them.
- Lack of transport.
- Lack of coordinated working across, Schools, ELBs, Health, Colleges etc
- Some interesting pilot projects Springvale Training Centre.
- Teachers not invited to monthly transition review panels which decide where pupils go to on transition.
- Review panels should occur.
- Health reluctant to speak to schools or see the children where they are happy.
- Nobody from the colleges or day-care to come into schools and work with pupils for their last year or two to guide them into their new environment.
- Lack of options for pupils in terms of choice of curriculum or accreditation on offer.
- Why can there not be age appropriate centres.
- Children with challenging behaviours can end up in Muckamore Hospital because of the lack of support when they leave.
- Children go on courses and because of lack of support they drop out.
- Some children fall in the gaps to severe to go to colleges but no medical need to get in to day-care centre.
- All the work of communication is lost when they leave school.
