Meeting

On arrival the Committee received a presentation on the work of the Southern Health & Social Care Trust regarding individuals with learning disabilities (a copy of the presentation is attached) followed by an informal discussion. The Committee was then given a brief tour of the facilities available.

Issues raised

- Children's services are better resourced that adult services.
- Resourcing Transforming Your Care is a problem.

- The staff acknowledge that the Oakridge building is inadequate the RQIA did not raise it as a problem.
- It is a challenge to accommodate highly complex service users in the space available at Oakridge.
- Representatives noted that there are failures and that there has to be certainty over the right facilities for individual's needs.
- Community Access teams oversee services for those with learning and physical disabilities because there is very often an overlap in need.

- Banbridge Locality -Banbridge SEC (new con joined centre in progress)
- Armagh & Dungannon Locality- Appleby SEC, Armagh; Mc Cague Day Centre in Aughnacloy; Coalisland Day Centre; Oakridge SEC in Dungannon (plans for replacement centre)



Future plans for buildings based day care

- Day Care services will be for those persons assessed as having the most complex care and support needs requiring intensive rehabilitation, on-going care and support in a specialist environment.
- Staff skills mix in day care services will extend to support implementation of rehabilitative and maintenance programmes.

- Person Centred Model of Care
- Needs led service
- Partnership working with service users, carers and within the Trust
- Promote independence, develop self advocacy, inclusion and meet physical, personal and emotional needs in a dignified, private and fulfilling manner.
- Look beyond traditional models of provision

Community access

The Community Access Generic Service

- Plans and develops community-based opportunities to link persons with disabilities with leisure, social training, supported employment, education, volunteering and enterprise opportunities in their local area;
- Maintains close working relationships with colleagues across other departments in the Trust, Private, Voluntary, Community and Statutory Organisations in creating and maintaining a range of person-centred community-based activities for persons referred to the service;
- Works in partnership with Service Users and their families in achieving high quality outcomes within Day Time Opportunities Programmes;
- Highlights and promotes equality of opportunity for disabled persons with all relevant organisations.
