Young People with Learning Disabilities Event

South Western Regional College, Enniskillen, 21 May 2015

Main themes and issues coming from the event

1. Further Education

- Special Education schools are excellent in Fermanagh area however, there is a lot of fear around what happens Post 18.
- Individual's in the group mainly stayed in school until age of 19.
- There were apprehensions around leaving friends although they looked forward to new opportunities.
- Lack of course choices either Gardening or College.
- Feeling that there was no choice after school.
- Important to parents that they can have this break during the day while child is safe and enjoying themselves- big emphasis placed on this rather than what the individual wants.
- If not enough numbers for a course then it doesn't go ahead.
- Transport to college / placement is an issue.
- Sometimes have to travel to a different college to do the course you want.
- Access to other programmes not dedicated to learning disability, not the same level of support. Concerns over safety, 1:1 support, more isolating for young person, concerning for parents and individuals felt worried as their parents are worried.
- Individuals were happy during classes and felt supported.
- More choice needed for when course finishes including placements.

2. Increased Opportunities to Work

- Lack of support and no advice or guidance given.
- People are volunteers and no one in the group had paid employment or felt that this would be a realistic aspiration.
- There was an emphasis on respite for parents rather than meaningful opportunities for individuals.

- There was very little contact with Social Workers.
- One individual advised that she would love to have a placement/ job in a beauty salon but no one has asked her before.
- Rural Lift have changed payment (2 days at normal rate & 2 days at double rate). This has major implications for many people in rural areas.
- Employers have a lack of knowledge of Learning Disabilities employers need support.
- Age prevents getting on further courses.
- Lots of competition for any jobs advertised. Never get interviews so lose interest.
- Want to work but transport an issue overcrowded buses.
- Falls on parent to take individuals to their activities.
- Very early mornings late evenings because of transport.
- Not many opportunities when Grant Aid stops there is no opportunity for full time work.

3. Community & Leisure Facilities

- Individuals enjoyed getting out and participating in leisure activities such as swimming or attending concerts, watch football.
- Transportation is a big issue as unable to get to activities.
- Society's views on disability impacting family decisions on where to go, activities to avail of.
- It is an opportunity to meet friends.
- Leisure facilities are expensive.
- Rely on transport from parent can't go if parents are not available to transport.
- Sometimes go to cinema if transport is available.

4. Day Care / Day Opportunities

- An individual has work placement for 6 weeks on Thursday afternoon in college. It is a volunteer role supporting new starts in the course she completed the previous year.
 Monday, Tuesday and Wednesday in college and Thursday and Friday in day care.
- In the summer when college is closed everyone is offered an extra day at day care.
- The day care programme is more relaxed and flexible and there are more trips in the summer.

- More is needed about opportunities available to young people.
- Transportation is a big issue especially for people living in rural areas. Fermanagh Community Transport – issues re: funding £5 per day approx. used to be £3. Have to get up early to get the bus. Parents bring if there is no bus.
