1. Apologies

2. Draft minutes of meeting of 25 November 2014

Agreed: the Committee agreed the draft minutes of 25 November 2014.

8. Legislation: Insolvency (Amendment) Bill

Agreed: to ask both the Insolvency Technical Committee and PricewaterhouseCoopers to provide oral evidence to the Committee on the issue at next week's meeting.

Agreed: members agreed the draft motion to extend the Committee Consideration Stage. The Motion was then laid in the Business Office.

4. Oral Briefing from DETI and BT : Northern Ireland Broadband Improvement Project

The representatives joined the meeting at 10:20am

> Members received an oral briefing from Mr Mike Thompson, Head of Tourism, Telecoms and Geological Survey Policy Division, DETI, Mr Trevor Forsythe, Project Manager, DETI, Mr Frank McManus, Head of Wholesale Sales and Service, BT, and Mr Alan Irwin, Head of Major Bids, Wholesale NI, BT

> Key issues discussed included: the fibre network, generation broadband, rural proofing, problems with customers in Northern Ireland accessing the RTÉ Player, capacity for businesses to grow inhibited due to lack of broadband, the super connected cities project, planning issues, inequalities in broadband speeds affecting businesses and the 4G Rollout.

Agreed: to write to DARD regarding broadband rollout in areas of deprivation. *Agreed:* to receive a quarterly update on the project. *Agreed:* to receive a copy of the rural proofing document.

Agreed: members to confirm with the Committee Office if they wish to accept BT's invitation to accompany engineers when installing broadband in their constituencies.

Agreed: to write to BT on the issue of the RTÉ Player.

5. Oral Briefing from DETI: Legislative Consent Memorandum – UK Small Business, Enterprise and Employment Bill

The representatives joined the meeting at 11:30am

Members received an oral briefing from Mr Keith Brown, Head of Financial Capability, Mutuals & Company Law, Ms Fiona McCausland, Head of Business Development Unit and Mr Jack Reid, Deputy Principal/Insolvency Service.

Key issues discussed included: what the provisions in the Bill would extend to with regards access to finance, company transparency, company filing requirements and company Directors' disqualification, whether it would have been more appropriate to include the proposed measures in an NI Bill rather than legislated for by Westminster through an LCM and why the LCM has not been extended to include provisions for Westminster to legislate on statutory regulations for Insolvency Practitioners.

The Committee moved to Agenda Item 7

7. Matters Arising

Members considered a response from DETI to the Committee's queries in respect of the Departmental response to the Electricity Policy Review – Part II – Security of Supply.

Agreed: to ask the Department, when it is responding to Part III of the Review, to provide a clear response to the Committee in table form on its level of support for each of the recommendations in the three parts of the Review, the reasons why for those not supported and actions it will take, is taking or has taken to implement each of the recommendations its supports.

Agreed: to write to NIE, the Utility Regulator, SONI and DoE Planning in relation to recommendations applicable to them, and to ask for a response by the end of January.

Members considered correspondence from Manufacturing NI in response to the Electricity Policy Review, Part II, Security of Supply.

Agreed: Members agreed to consider Manufacturing NI's response to Part II when considering the Department's future response.

Members noted a response from the Department of Finance and Personnel for an update on Small Business Rate Relief further to the Committee's queries following the Northern Ireland Centre for Economic Policy (NICEP) briefing to the Committee.

Members noted a response from the Utility Regulator regarding the planned publication of a paper on the potential cost to consumers that creating the additional electricity will bring.

Members considered the announcement of the withdrawal of First Flight Wind from Northern Ireland

Agreed: to write to the Department for information on what exactly the issues and obstacles were for the company and what this announcement may mean to Northern Ireland in terms of security of supply.

9. Legislation: The Domestic Renewable Heat Incentive Scheme Regulations (Northern Ireland) 2014

Members noted that the Examiner of Statutory Rules has considered this Statutory Rule and has indicated the points that he has raised with the Department and which have subsequently been agreed to and changed by the Department.

Agreed: that the Committee for Enterprise, Trade and Investment has considered the Statutory Rule – The Domestic Renewable Heat Incentive Scheme Regulations (Northern Ireland) 2014 and, subject to the ESR's report, recommends that it be affirmed by the Assembly.

10. Written Briefing from DETI: January Monitoring Round

No papers were received from the Department for this item of business. Therefore this item of business was not discussed.

6. Oral Briefing from DETI: Budget 2015/2016

The representatives joined the meeting at 11:54am

Members received an oral briefing from Mr Eugene Rooney, Head of Management Services Group, Trevor Cooper, Head of Finance Division and Ms Bernie Brankin, Principal Officer, Finance Branch.

Key issues discussed included the impact of proposed reductions on the Economic Strategy and Programme for Government commitments, reducing the number of staff within the Department and its ALBs, funding for the Cross Border bodies, Invest NI's budget, reductions in the HSENI budget for farm safety campaigns and the Department's Financial Transaction Capital budget.

Agreed: to receive a copy of the administration and programme table which the representatives had at the meeting; to ask the Department to confirm that, as was stated by the Executive, no viable Job Creation Scheme will be lost due

to financial constraints; to ask for a comparison year on year from 2008 of percentage change in the InterTradeIreland and Tourism Ireland budgets and comparison percentage change of the DETI budget, also a comparison in monetary value; to ask what proportion of DETI's allocated budget is already contractually committed; to ask for further information on the figures secured from Europe; and to ask, DETI had previously been rewarded FTC funding for the implementation of the agri-food loan scheme and this was surrendered during the January 2014 monitoring round due to delays in the scheme. DETI's budget document proposes that FTC funding will again be allocated to the agri-food loan scheme in 2015/16. Is the loan scheme now operational and how confident is DETI that the FTC set aside for this purpose in 2015-16 will be utilised, or is there a risk of further delay.

Agreed: to write to the Committee for Finance and Personnel highlighting the inadequacies of the current process and informing its members that the Committee only received papers from the Department for tabling at this week's meeting and will not be in a position to consider and agree a report until the next Committee meeting on 9^{th} December.

Agreed: to write to the Committee for Agriculture and Rural Development for comment regarding the proposal to suspend the current farm safety campaign activity.

Agreed: to write to the Ulster Farmers' Union and the Northern Ireland Agricultural Producers' Association for comment regarding the proposal to suspend the current farm safety campaign activity.
