confirmation of a date for the Ministerial briefing.

5. Equality and Human Rights - RaISe Briefing on International Human Rights Standards

6. Equality and Good Relations – NI Human Rights Commission on the NI Executive's Engagement with UN Reporting Cycles

Representatives from the Northern Ireland Human Rights Commission joined the meeting at 2.26 pm.

The Committee heard evidence from Mr Les Allamby, Chief Commissioner, and Dr David Russell, Deputy Director, on the engagement of the NI Executive with International Human Rights treaties.

A question and answer session followed. The session was recorded by Hansard.

Mr Stalford pointed out that it had been established that a former Health Minister did not make comments attributed to him in paragraph 37 of the European Commission against Racism and Intolerance's fifth monitoring cycle report.

The Chief Commissioner agreed to forward a copy of the NIHRC submission on the Programme for Government consultation to the Committee.

7. Equality and Good Relations – Equality Commission NI, Human Rights Consortium, and Mr Patrick Yu

Representatives from the Equality Commission for Northern Ireland (ECNI), the Human Rights Consortium and Patrick Yu, former Director of NI Council for Ethnic Minorities (NICEM) joined the meeting at 3.29 pm

The Committee heard evidence from Dr Michael Wardlow, Chief Commissioner, ECNI; Mr Paul Noonan, Senior Policy Officer, ECNI; Ms Helen Flynn, Campaign and Membership Officer, Human Rights Consortium; and Mr Patrick Yu, former Executive Director, NICEM on the engagement of the NI Executive with International Human Rights treaties.

A question and answer session followed. The session was recorded by Hansard.

The Chief Commissioner agreed to forward a copy of a paper highlighting gaps in equality legislation between GB and NI; and a copy of the ECNI submission on the Programme for Government consultation.

Agreed: To write to the First Minister and deputy First Minister to

encourage full participation on behalf of the Executive in forthcoming UN treaty reporting cycles, and in particular next

year's Universal Periodic Review.

Agreed: To request information on the possible implications of the UK's

exit from the EU on equality legislation.

8. Subordinate Legislation - Departments (Transfer of Functions) Order (NI) 2016

The Committee noted responses from Committee for Agriculture, Environment and Rural Affairs, the Committee for Infrastructure and the Committee for Communities advising that they are content with the Executive Office's proposal to bring forward a draft Transfer of Functions Order.

Agreed: To advise the Executive Office, on behalf of the relevant

Committees, that this Committee is content with the draft Order.

Archbishop Martin - Historical Institutional Abuse

The Committee noted a response from Archbishop Eamon Martin to comments made by some representatives of the Panel of Experts on Redress during the meeting of 28 September. The Archbishop provided the Committee with a copy of a statement made on the evening of 28 September; a copy of a statement issued on 5 July following a meeting between the Archbishop and the Panel of Experts on Redress; and an extract from his Opening Address given to the Annual conference of the National Board for Safeguarding Children in the Catholic Church on 14 October.

Agreed: To write to the Chairpersons' Liaison Group to encourage

Chairpersons to remain mindful of affording the opportunity for

people to respond to comments made about them during Committee meetings at which they are not present.
