SL1 – The Rates (Unoccupied Hereditaments) (Amendment No.2) Regulations (NI) 2013

Agreed: that the Committee has considered DFP's proposal for subordinate legislation under The Rates (Unoccupied Hereditaments) (Amendment No.2) Regulations (NI) 2013 and has no objection to the policy implications of the proposed legislation at this stage.

Agreed: to write to the Department to seek background information and clarification on the lump sum payment offers made by DFP to some of the plaintiffs whose claims were dismissed in the recent County Court judgement; including the timing of these offers, the rationale for the Department making the offers, and the basis on which the offers were rejected. Also, to request information on what will happen to the £26m ring-fenced for the Equal Pay settlement and on the options open to those people whose claims have been dismissed.

Agreed: to write to NIPSA to seek background information and clarification on the lump sum payment offers made by DFP to some of the plaintiffs whose claims were dismissed in the recent County Court judgement; including on any advice NIPSA provided to those staff regarding the lump sum payments, and on whether the offers were rejected on the basis of that advice. Also, to request information on the options open to those people whose claims have been dismissed.
