# 1. Apologies

## 3. Matters Arising

Table of Requests for Information from the Department of Finance and Personnel (DFP)

The Committee noted the table of requests for information from DFP which provided an update on any matters arising not covered elsewhere on the agenda.

# 4. Defamation Act 2013 – Evidence from Libel Reform Campaign

The Committee received evidence on the Defamation Act 2013 from the following witnesses: Michael Harris, Head of Advocacy, Index on Censorship; Jo Glanville, Director of English Pen; Dr Sile Lane, Sense About Science; and Dr Peter Wilmshurst, Senior NHS Cardiologist. The evidence session was recorded by Hansard.

Agreed: that the witnesses will provide follow up information as discussed during the session.

## 5. Defamation Act 2013 – Evidence from Northern Ireland Human Rights Commission

The Committee received evidence on the Defamation Act 2013 from the following representatives of the Northern Ireland Human Rights Commission: Virginia McVea, Director; Angela Stevens, Case Worker; and Colin Caughey, Policy Worker. The evidence session was recorded by Hansard.

Agreed: that the witnesses will provide follow up information as discussed during the session.

# 6. Defamation Act 2013 – Evidence from DFP

The Committee received evidence from the following DFP officials; Oswyn Paulin, Departmental Solicitor, Departmental Solicitors Office (DSO); and Laura McPolin, Policy Advisor, DSO.

Agreed: to take up the offer by the Editor of the Belfast Telegraph, Mike Gilsen, to brief the Committee on this issue.

Agreed: to commission background research into the approaches adopted by the Scottish Parliament and the Oireachtas with respect to defamation law.

### 7. Bank branch closures

Members noted a briefing paper from the Consumer Council on "Access to Branch Banking".

The Chairperson informed members that communication had been received from the Managing Director of First Trust Bank to notify the Committee of the planned closure of four bank branches. The Committee recorded its appreciation for this notification and members discussed the way forward in light of this and the recent announcement by Ulster Bank about branch closures.

Peter Weir declared an interest as a customer of the Ulster Bank.

Daithí McKay declared an interest as a former employee of the Ulster Bank.

Agreed: to invite representatives of both the Consumer Council and the Ulster Bank to provide oral briefings on the recent announcements regarding bank branch closures and how this will affect consumers. Members also indicated that they would like to hear from the Ulster Bank on the options on the way forward for banking in rural areas.

Agreed: that the Committee will also write to the other main local banks to outline its concerns on this matter.

Agreed: that, given the cross-cutting nature of this matter, the Committee will liaise with the Committee for Enterprise, Trade and Investment in taking forward this scrutiny as appropriate. In the event that the Committee for Finance and Personnel takes the lead in this instance, members of the Committee for Enterprise, Trade and Investment will be invited to attend the oral briefings and to question witnesses.
