Agreed: Question accordingly agreed to.

Members noted correspondence from the Examiner of Statutory Rules explaining that he had not undertaken a technical scrutiny of the Civil Service Compensation Scheme (Amendment) Scheme (NI) 2014 because it is outside his terms of reference under Standing Order 43 as it is not a statutory rule. However, it was noted that this gap could be addressed in future through a special technical scrutiny function with arrangements for special reports to the Committee being devised for schemes under Article 3 of the Superannuation (Northern Ireland) Order 1972.

Agreed: to write to DFP to highlight the views of the Examiner of Statutory Rules regarding the accessibility of schemes under Article 3 of the Superannuation (Northern Ireland) Order 1972, including that they be made available online to facilitate scrutiny.

4. Principal Civil Service Pension Scheme (Amendment) Scheme (Northern Ireland) 2014

Members noted this scheme amendment was consequential to the Civil Service Compensation Scheme (Amendment) Scheme (NI) 2014 and was not subject to any Assembly procedure.

5. SR 67/2014: The Valuation (Telecommunications, Natural Gas and Water) (Amendment) Regulations (Northern Ireland) 2014
