3. Matters Arising

Table of requests for information from the Department of Finance and Personnel (DFP)

The Committee noted the summary table of requests for information from DFP which provided an update on any matters arising not covered elsewhere on the agenda.

<u>Legislative Consent Motion (LCM) – Powers to prevent transfers out of unfunded, defined benefit, public service pension schemes to defined contribution pension schemes.</u>

Members discussed correspondence received from DFP on 21 October 2014 relating to a proposed LCM to extend provisions in the Westminster Pension Schemes Bill to Northern Ireland, which would prevent transfers out of unfunded, defined benefit, public service pension schemes to defined contribution pension schemes.

Agreed: to write to the Department expressing the Committee's concern over the late notice of the proposed LCM and to indicate that, as a consequence, the Committee would not have sufficient time to report its opinion on the proposed LCM to the Assembly based on the timetable presented.

Agreed: to schedule an oral hearing from the responsible departmental officials at the next Committee meeting on 5 November 2014.

Agreed: to circulate the correspondence from the Department to the other relevant Assembly committees for information.

4. Validation Study of Welfare Reform Costs – Review of Terms of Reference

The Committee discussed the terms of reference for the 'Welfare Reform Costs - Validation Study', which DFP commissioned for the purpose of providing an independent assessment of the economic impact on Northern Ireland of not progressing the Welfare Reform agenda in line with Great Britain.

Members noted that the Committee was not afforded the opportunity to input to the terms of reference prior to work on the Study commencing. Some members queried how the Study

would also assess the repercussions of implementing Welfare Reform in Northern Ireland, particularly for individuals.

Agreed: that members could write to DFP directly for clarification on how the Study will address particular issues of concern.

Agreed: to forward all relevant correspondence on the Study to the Committee for Social Development for information given the cross-cutting nature of this issue.
