Arising from the evidence received on 28 January 2015 and press coverage of the Westminster passage of the Corporation Tax (Northern Ireland) Bill, the Committee noted concern over aspects of how the cost to the Northern Ireland Executive of any reduction in corporation tax rates will be calculated following devolution of the power to the Assembly. In particular, as previously highlighted in the Committee's Report on the Draft Budget 2015-16, the concern relates to whether the value of the benefits accruing to the UK Government from increased economic activity arising from reduced corporation tax rates in Northern Ireland, including additional yield from income tax and VAT and reduced welfare payments, will be offset against the costs to the block grant.

Agreed: to write to the Minister seeking further information on this issue and an assurance on efforts to secure agreement from the UK Government on the matter.
