# 7. SR 2015/123 The Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2015

Members considered the DFP papers relating to this statutory rule, together with the related report by the Examiner of Statutory Rules, which was published on Friday 13 March 2015. The Examiner had confirmed that he was raising no points about the Rule by way of technical scrutiny.

*Agreed:* that the Committee has considered SR 2015/123 The Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) and has no objection to the rule.

#### SR 2015/141 The Superannuation (District Councils) Order (Northern Ireland) 2015

The Committee considered the DFP papers relating to this statutory rule.

Members were informed that the Examiner of Statutory Rules has identified an issue with the rule arising from his technical scrutiny, upon which he is liaising with the Department.

*Agreed:* to reschedule Committee consideration of SR 2015/141 to a date when the Examiner has reported on the matter.

Members noted that the statutory period expires on 28 April 2015, allowing time for further Committee scrutiny.
