Agreed: to write to the Department of Finance and Personnel (Northern Ireland) and the Department of Finance (Republic of Ireland), in light of the evidence received from Mr Graham, to request information on the criteria applied and processes followed for nominating and appointing members to NAMA's Northern Ireland Advisory Committee and to ascertain where responsibilities lay for due diligence in respect of the nominees and appointees in this regard.

Agreed: to write to Fortress Investment Group inviting it to provide an oral briefing in relation to the Committee's Review.

Agreed: to write to Mr Frank Cushnahan inviting him to respond to the evidence presented at today's session.

## 6. Review of the sale of National Asset Management Agency (NAMA) assets in Northern Ireland – Correspondence and Next Steps.

Members considered email correspondence from former Minister of Finance and Personnel, Mr Sammy Wilson MP, which responded to the Committee's invitation for him to give oral evidence in relation its Review.

Agreed: that, in light of the evidence received from Mr Graham, the Committee will write to the former Minister of Finance and Personnel, Mr Sammy Wilson MP, to reiterate its request for oral evidence in relation to the Review, including information on the criteria or basis for making nominations for appointment to NAMA's Northern Ireland Advisory Committee, and to respond to his request for advice on the National Crime Agency's views on the Committee's Review Terms of Reference.

Agreed: to write to Tughans to ascertain the reason for the apparent delay in reporting the issues relating to Mr Ian Coulter to the Law Society of Northern Ireland and to seek clarification on where the monies in respect of the Cerberus payment are held.

Agreed: to commission Assembly Research to provide an update of its paper entitled 'NAMA's Sale of the Northern Ireland Property Loan Portfolio – Timeline'
