### 4. Rates (Amendments) Bill – Briefing from Sports Groups

Members received a briefing on the November Monitoring Round from the following officials:

*Agreed:* to write to the Department of Environment for information on previous work, commissioned by the then Minister, Mr Edwin Poots MLA, on the cost of extending rate relief to amateur sports clubs.

Agreed: to enquire from DFP: what the additional cost would be of extending the enhanced rate relief, which is proposed for unlicensed Community Amateur Sports Clubs (CASCs) under the Rates (Amendment) Bill, to enable those CASCs with liquor licences to also avail of the 100% relief on their sports facilities (while continuing to pay 100% rates on the licenced part of their premises); and whether this can be achieved through the proposed Regulations.

*Agreed:* to commission research into the discretionary 20% rate relief provided to amateur sports clubs by local authorities in Great Britain and on whether legislative change would be required to apply similar provision in Northern Ireland.

Agreed: to write to the umbrella organisations for both the membership-based and privately owned golf clubs in Northern Ireland to seek their views on the proposal for enhanced rate relief for CASCs under the Rates (Amendment) Bill.

### 5. Legal Complaints and Regulation Bill – Initial consideration of draft report

The Committee considered an initial draft report on the Legal Complaints and Regulation Bill.

Agreed: that members will provide Committee staff with any suggested additions or amendments to the draft report by the end of the week, ahead of a final draft being considered for agreement on 9 December.
