'(5A) Regulations under subsection (1) may not make provision requiring the processing of information of a relevant person who has notified the data controller to cease, or not to begin, processing information in respect of which that person is the subject.'

Agreed: The Committee agreed that it was content with the wording of the revised amendment.

(ii) The Committee considered the Department's response to its request for clarification of the timeframe for the implementation of the proposals contained in the Commissioner for Older People's report: *Changing the Culture of Care Provision in Northern Ireland*.
