## 2. Chairperson's Business

iv. The Chairperson referred to her recent meeting with representatives of the Registration Council for Clinical Physiologists.

Agreed: The Committee agreed to write to the Department for its assessment of the current voluntary registration for clinical physiologists and its views on placing the registration on a statutory footing.
