# 7. SL1 The Food Hygiene (Amendment) Regulations (Northern Ireland) 2016

The Committee considered a proposal for a statutory rule to amend The Food Hygiene Regulations (Northern Ireland) 2016 further to an EU Commission Implementing Regulation laying down rules on official controls for Trichinella in meat.

Agreed: The Committee agreed that it was content that the Department make the statutory rule.

### 8. SL1 The General Dental Service (Amendment No. 2) Regulations (Northern Ireland) 2016

The Committee considered a proposal for a statutory rule to amend the General Dental Services Regulations (Northern Ireland) 1993 to update terminology, legislative references and the objectives and requirements of postgraduate dental training.

Agreed: The Committee agreed that it was content that the Department make the statutory rule.

### 9. Correspondence

i. The Committee considered correspondence from the Department of Health providing an update on the transposition of the revised Mutual Recognition of Professional Qualifications EU Directive into domestic legislation governing the UK healthcare regulators.

Agreed: The Committee agreed to invite the Department to brief the Committee on this matter.

ii. The Committee considered correspondence from the National Community Hearing Association regarding hearing service provision in Northern Ireland.

Agreed: The Committee agreed to invite the National Community Hearing Association to a future Committee stakeholder event.

iii. The Committee considered correspondence from the Northern Ireland Commissioner for Children and Young People requesting to meet with the Chairperson and Deputy Chairperson to discuss how NICCY can work with the Committee in relation to health matters.

Agreed: The Committee agreed that the Chairperson would respond directly to NICCY regarding this request.

iv. The Committee considered correspondence from Fitzone Foundation requesting support for the promotion of their latest health challenge #Raisethebeat.

Agreed: The Committee agreed to consider this invitation when deciding on its engagement strategy.

v. The Committee considered correspondence from an individual regarding a complaint against the Belfast Health and Social Care Trust.

Agreed: The Committee agreed to write to the individual to advise them of the role of the Committee and to recommend that they contact their local MLAs.

vi. The Committee considered a request from Community Development and Health Network to brief the Committee on its work in relation to Public Health issues and tackling health inequalities.

ix. The Committee considered the Prisoner Ombudsman's Investigation Report into the circumstances surrounding the death of Patrick Kelly on 20 March 2016.

Agreed: The Committee agreed to request a briefing from the South Eastern Health and Social Care Trust and the Prisoner Ombudsman on the provision of mental health care for prisoners.

x. The Committee considered correspondence from the Law Centre NI regarding the Independent Guardian service.

Agreed: The Committee agreed to advise the Law Centre that further to discussions with the Minister, the Committee expects to see progress on this matter shortly and to provide any information from the Department to the Law Centre when received.

xi. The Committee considered correspondence from the Public Health Agency requesting that the Committee support a campaign to mark World Mental Health Day on 10 October 2016.

Agreed: The Committee agreed to take part in publicity to support the campaign.

xii. The Committee considered an invitation from the Coroners Service for Northern Ireland to a Medico-Legal Colloquium in Parliament Buildings on 11 October 2016.

Agreed: The Committee agreed that Members should advise the Coroners Service if they wish to attend this event.
