The meeting commenced at 2.10 p.m. in public session.

#### 1. Apologies

#### 2. Draft minutes of the meeting held on 3 March 2016

The Committee agreed the minutes of the meeting held on 3 March 2016.

#### 3. Matters Arising

The Chairman outlined information he had received from the Department of Justice clarifying the position regarding the roll out of the domestic violence court listing arrangements in Londonderry Courthouse to other courts following a recent media article and advised that a copy was available in the Committee Office.

### 4. Reducing Avoidable Delay in the Criminal Justice System – Progress Report on the Programme of Work – March 2016

Ms Karen Pearson, Deputy Director, Criminal Justice Division, Department of Justice, Chief Superintendent Stephen Cargin, Legacy and Justice Branch, PSNI and Mr Ciaran McQuillan, Assistant Director, Public Prosecution Service joined the meeting at 2.12 p.m.

Ms Pearson outlined the current position in relation to the programme of work to reduce avoidable delay in the criminal justice system and the current performance at the various court levels.

#### 2.25 p.m. Mr Alex Attwood joined the meeting.

A question and answer session followed covering issues including: the main obstacles to making progress to address avoidable delay in the criminal justice system; the deteriorating performance in the Crown Court against targets; the causes of delay in crown court cases; the likely impact of dealing with the backlog of cases in the Crown Court and whether performance against targets would deteriorate further; reasons for improvements in the youth courts; whether any substantive improvement to tackle avoidable delay had been made in the last five years; examples of closer engagement between the PPS and the PSNI including the case files project; whether the working relationship between the PSNI and PPS had improved; the extension of the Crown Court pilot project to other serious cases including murder/manslaughter cases; the reasons for improvements demonstrated in the pilot project; the main reasons for adjournments; whether there is an unacceptably high level of adjournments; whether more robust case management is required; examples of good practice in other jurisdictions; why serious cases in England and Wales are dealt with much quicker; and the transferability of approaches and practices in other parts of the UK.

The Chairman thanked the officials for their attendance and they left the meeting.

The Committee considered The Police (Performance and Attendance) Regulations (Northern Ireland) 2016 which makes provision for unsatisfactory performance and attendance procedures for members of the PSNI.

Agreed: The Committee considered SR 2016/42 The Police

(Performance and Attendance) Regulations (Northern Ireland)

2016 and had no objection to the Rule.

#### 7. SR 2016/43 The Police Appeals Tribunals Regulations (Northern Ireland) 2016

The Committee considered The Police Appeals Tribunals Regulations (Northern Ireland) 2016 which makes provision for Police Appeals Tribunals for members of the PSNI.

Agreed: The Committee considered SR 2016/43 The Police Appeals

Tribunals Regulations (Northern Ireland) 2016 and had no

objection to the Rule.

## 8. SR 2016/58 The Criminal Justice Act 1988 (Review of Sentencing) Order (Northern Ireland) 2016

The Committee considered The Criminal Justice Act 1988 (Review of Sentencing) Order (Northern Ireland) 2016 which will add a range of offences to the Unduly Lenient Sentencing Scheme.

Agreed: The Committee considered SR 2016/58 The Criminal Justice

Act 1988 (Review of Sentencing) Order (Northern Ireland)

2016 and had no objection to the Rule.

### 9. SR 2016/74 The Damages for Bereavement (Variation of Sum) (Northern Ireland) Order 2016

The Committee considered The Damages for Bereavement (Variation of Sum) (Northern Ireland) Order 2016 which will increase the level of bereavement damages in Northern Ireland in line with inflation as measured by the Consumer Price Index for January 2016 to £14,200.

and had no objection to the Rule.

# 10. SR 2016/81 The Modern Slavery Act 2015 (Power of Arrest: Code of Practice) Order (Northern Ireland) 2016

The Committee considered The Modern Slavery Act 2015 (Power of Arrest: Code of Practice) Order (Northern Ireland) 2016 which will bring into operation a Code of Practice to be followed by Northern Ireland constables and enforcement officers when exercising new maritime enforcement powers under Part 3 and Schedule 2 of the Modern Slavery Act 2015.

Agreed: The Committee considered SR 2016/81 The Modern Slavery

Act 2015 (Power of Arrest: Code of Practice) Order (Northern

Ireland) 2016 and had no objection to the Rule.

### 11. SR 2016/82 The Police Pensions (Additional Voluntary Contributions) (Amendment) Regulations (Northern Ireland) 2016

The Committee considered The Police Pensions (Additional Voluntary Contributions) (Amendment) Regulations (Northern Ireland) 2016 which will allow members of the PSNI who are retiring with a protected pension age before 55 or aged 55 or over, to no

longer be required to purchase an annuity from their AVC pension provider with effect from 6 April 2015.

Agreed: The Committee considered SR 2016/82 The Police Pensions

(Additional Voluntary Contributions) (Amendment)

Regulations (Northern Ireland) 2016 and had no objection to

the Rule.

## 12. SR 2016/90 The Taxis Act (Northern Ireland) 2008 (Retention and Disposal of Seized Motor Vehicles, Equipment and Items) Regulations (Northern Ireland) 2016

The Committee considered The Taxis Act (Northern Ireland) 2008 (Retention and Disposal of Seized Motor Vehicles, Equipment and Items) Regulations (Northern Ireland) 2016 which will provide the arrangements by which the seizure of vehicles and equipment will be regulated where it is suspected that the vehicle is being operated as a taxi without proper licence.

Agreed: The Committee considered SR 2016/90 The Taxis Act

(Northern Ireland) 2008 (Retention and Disposal of Seized Motor Vehicles, Equipment and Items) Regulations (Northern

Ireland) 2016 and had no objection to the Rule.

#### 13. SR 2016/93 The Magistrates' Courts (Amendments) Rules (Northern Ireland) 2016

The Committee considered The Magistrates' Courts (Amendments) Rules (Northern Ireland) 2016 which sets out the procedure to be followed in relation to an application from the defence for an order for access to premises as provided for by Section 94 of the Justice Act (Northern Ireland) 2015.

no objection to the Rule.

## 14. SR 2016/94 The Magistrates' Courts (Violent Offences Prevention Orders) Rules (Northern Ireland) 2016

The Committee considered The Magistrates' Courts (Violent Offences Prevention Orders) Rules (Northern Ireland) 2016 which will amend the current Magistrates' Courts Rules framework to provide four template forms to be used by the courts in processing applications for a Violent Offences Prevention Order (VOPO) and four specific rules for the courts in dealing with the VOPO.

(Violent Offences Prevention Orders) Rules (Northern Ireland)

2016 and had no objection to the Rule.
