## 2. Draft minutes of the meeting held on 25 February 2016

The Committee agreed the minutes of the meeting held on 25 February 2016.

## 3. Matters Arising

i. The Chairman advised the Committee that the briefing on the current position regarding the Desertcreat Community Safety Training College capital project scheduled for the meeting on 10 March 2016 would take the form of a written paper.

### 4. Update on the Scoping Study on Children in the Justice System – March 2016

Mr Declan McGeown, Chief Executive, Ms Mary Aughey, Director of Youth Justice Services and Mr Brian Ingram, Director of Custodial Services, Youth Justice Agency, and Ms Kiera Lloyd, Reducing Offending Policy Unit, Department of Justice joined the meeting at 2.19 p.m.

Mr McGeown outlined the current position regarding the Scoping Study on Children in the Justice System.

A question and answer session followed covering issues including: what opportunities had been provided for the voluntary groups to assist in shaping the proposals; the level of engagement by the Department with the NGOs on the Scoping Study; whether the proposals will require legislative changes and if so what areas are likely to be covered and what is the anticipated timescale; what monitoring and oversight arrangements will be put in place to ensure that the next programme of work will be delivered; the level of cross departmental commitment and collaboration that exists; the types of offences that can be dealt with by the proposed welfare approach; the nature of the Minister of Justice's planned oral statement to the Assembly and whether it would include detailed proposals; the timescale for the provision of detailed proposals; whether there would be an implementation plan; the impact of budgetary pressures in relation to education provision in the Juvenile Justice Centre; whether youth justice was likely to remain in the Department of Justice or sit within another Department such as Education or Health; the role of the Director General of the NI Prison Service in relation to youth justice; the need to remove youth justice away from the NI Prison Service; the timescale for implementing the proposals; barriers to the proposals going forward; the role of the NI Commissioner for Children and Young People in relation to the Scoping Study; the lack of action to reduce PACE numbers; the approach in relation to 'looked after' children and best practice in other jurisdictions; working with high risk young offenders; work with OFMDFM on the Children's Strategy; the level of response to the Scoping Study and whether there were difficulties engaging with parents and young people; and whether there are examples of children whose needs cannot be met within Northern Ireland.

The Chairman thanked the officials for their attendance and they left the meeting.

The Committee noted the intention of the Minister of Justice to make an oral statement on the Scoping Study on Children in the Justice System in the Assembly on 14 March 2016.

# 5. SR 2016/57: The Mental Health Review Tribunal (Amendment) Rules (Northern Ireland) 2016

The Committee considered The Mental Health Review Tribunal (Amendment) Rules (Northern Ireland) 2016 which will provide the Mental Health Review Tribunal with the discretion to abridge time limits for proceedings where it is in the interests of justice to do so to ensure compliance with the European Convention.

*Agreed:* The Committee considered 2016/57 The Mental Health Review Tribunal (Amendment) Rules (Northern Ireland) 2016 and had no objection to the Rule.

### 6. SR 2016/48: The Modern Slavery Act 2015 (Duty to Co-operate with Commissioner) (Northern Irish Public Authority) Regulations (Northern Ireland) 2016

The Committee considered The Modern Slavery Act 2015 (Duty to Co-operate with Commissioner) (Northern Irish Public Authority) Regulations (Northern Ireland) 2016 which will make a number of public authorities in Northern Ireland subject to the duty to co-operate with the UK Independent Anti-Slavery Commissioner.

*Agreed*: The Committee considered SR 2016/48 The Modern Slavery Act 2015 (Duty to Co-operate with Commissioner) (Northern Irish Public Authority) Regulations (Northern Ireland) 2016 and had no objection to the Rule.

### 7. Programme for Government 2011 – 2015 - Update on Department of Justice Commitments – February 2016

The Committee noted an update from the Department of Justice on progress in relation to the seven commitments in the Programme for Government for which it has responsibility.

### 8. Implementation of the Access to Justice Review Recommendations – Progress Report – February 2016

The Committee considered a progress report from the Department of Justice on the implementation of the Access to Justice Review key areas to be taken forward and the projects outlined in the Departmental Action Plan 2012-15.

*Agreed*: The Committee agreed that it was content with the Department of Justice proposal that any outstanding work from the Departmental Action Plan should be absorbed into the new programme of work that will be developed to deliver the Access to Justice Review Part II.

## 9. Implementation of the Victim and Witness Strategy Action Plan 2015/2018 – Progress Report - February 2016

The Committee noted a progress report from the Department of Justice on the delivery of the 2015 – 2018 Victim and Witness Strategy Action Plan.

## 10. Strategic Framework for Reducing Offending – Progress Report - February 2016

The Committee noted the final report from the Department of Justice on progress to advance the strategic outcomes of the Reducing Offending Framework.

# 11. CJINI Inspection of Policing and Community Safety Partnerships – Update on Implementation of the Action Plan

The Committee noted an update from the Department of Justice on the delivery of the action plan in response to the recommendations within the Criminal Justice Inspection Northern Ireland report on Policing and Community Safety Partnerships: A Review of Governance, Delivery and Outcomes published in December 2014.

## 12. Review into the Implementation of the Welfare of Animals Act (Northern Ireland) 2011 – Final Report - February 2016

The Committee noted the Final Report of the Review into the Implementation of the Welfare of Animals Act (Northern Ireland) 2011 and the actions being taken by the Department of Justice in relation to the recommendations that fall within its remit.

An amendment was proposed to recommendation 3 to add the words 'whilst regrettable' so that the recommendation read: "The Committee considers that the recently announced rationalisation of the Court Estate by the Minister to the Assembly on 8 February 2016, *whilst regrettable*, provides an opportunity to think creatively about alternative uses for buildings once they cease to be fully functioning courthouses, including transformation into community justice centres which could house voluntary and citizen advisory organisations."

Mr Dickson highlighted that in his view the Minister had to make the court closures given the current budgetary pressures faced by the Department of Justice.

Agreed: The Committee agreed to amend recommendation 3 as proposed.

A proposal was made to include a number of photographs in the report.
