Clause 9, Page 4, Line 5

Leave out paragraph (a) and insert -

(a) in paragraph (5) (price limit on tickets) for "£1" substitute "£100".'

Clause 14, Page 6

Leave out from line 9 to line 15 on page 7 and insert-

'172A.It shall be a condition of all relevant licences, certificate or permits that the holder of a relevant licence, certificate or permit must make an annual financial contribution of 1% of their annual gross gambling yield to one or more organisations approved by the Department, which between them deliver or support research into the prevention and treatment of gambling-related harm, harm prevention approaches and treatment for those harmed by gambling".'

- (c) the gambling industry in Northern Ireland.'
