

# Harbours (Grants and Loans Limit) Bill

## LEGISLATIVE COMPETENCE

**BILL**

TO

Amend the Harbours Act (Northern Ireland) 1970 to increase the statutory limit on certain grants and loans for harbour works etc.

**B**E IT ENACTED by being passed by the Northern Ireland Assembly and assented to by Her Majesty as follows:

**Increase of limit on grants and loans for harbour works, etc.**

1.—(1) In section 4 of the Harbours Act (Northern Ireland) 1970 (limit on aggregate of loans and grants under sections 2 and 3 of that Act) for “£35 million” substitute “£90 million”.

5 (2) Article 4 of the Financial Provisions (Northern Ireland) Order 1989 (increase of limit on grants and loans for harbour works) is repealed.

**Commencement**

2. This Act comes into operation on the day after this Act receives Royal Assent.

**Short title**

10 3. This Act may be cited as the Harbours (Grants and Loans Limit) Act (Northern Ireland) 2020.
