Session 2014/2015 Thirteenth Report

- 1. In accordance with the delegations in respect of the technical scrutiny of statutory rules under Standing Order 43(4)(b) given to the Examiner of Statutory Rules by the appropriate Committees on 25, 26 and 31 May and 1 June 2011 for this mandate of the Assembly, I submit my report on the statutory rules listed in the Appendix.
- 2. My terms of reference are essentially set out in Standing Order 43(6) (taken with the delegations under Standing Order 43(4)(b)). They are as follows:
  - "(6) In scrutinising an instrument the appropriate Committee shall inter alia consider the instrument with a view to determining and reporting on whether it requires to be drawn to the special attention of the Assembly on any of the following grounds, namely, that
    - (a) it imposes a charge on the public revenues or prescribes the amount of any such charge;
    - (b) it contains provisions requiring any payment to be made to any Northern Ireland department or public body in respect of any approval, authorisation, licence or consent or of any service provided or to be provided by that department or body or prescribes the amount of any such payment;
    - (c) the parent legislation excludes it from challenge in the courts;
    - (d) it purports to have retrospective effect where the parent legislation confers no express authority so to provide;
    - (e) there appears to have been unjustifiable delay in the publication of it or in the laying of it before the Assembly;
    - (f) there appears to be a doubt whether it is intra vires or it appears to make some unusual or unexpected use of the powers conferred by the parent legislation;
    - (g) it calls for elucidation;
    - (h) it appears to have defects in its drafting;

or on any other ground which does not impinge on its merits or the policy behind it.".

# Statutory rules to which attention is drawn in this report

The Planning (Trees) Regulations (Northern Ireland) 2015 (S.R. 2015/84)

3. I draw the attention of the Committee for the Environment and the Assembly to the Planning (Trees) Regulations (Northern Ireland) 2015 (S.R. 2015/84) on the ground they are drafted defectively (or at least infelicitously) in one respect, acknowledged by the Department of the Environment. Regulation 10 (use of electronic communications) applies to tree preservation orders (Part 2); yet it is positioned in Part 3 (trees in conservation areas), although it does not relate to that Part. It seems that the previous (2003) Regulations, as amended in 2006, were drafted similarly. This infelicity does not affect the working of the Regulations but it does appear to be odd. If the Department is revising the Regulations in the future, it will address this point.

I draw the attention of the Committee for Employment and Learning and the Assembly to the above-mentioned Regulations on the ground they appear to be defectively drafted in one respect, acknowledged by the Department for Employment and Learning. They form part of the large suite of subordinate legislation to implement the Work and Families Act (Northern Ireland) 2015, and are made under various powers contained in the Employment Rights (Northern Ireland) Order 1996, including powers inserted in that Order by the 2015. They have been made subject to the confirmatory procedure: some of the powers are subject to that procedure and some subject to negative resolution. The problem is that, unlike the Social Security Contributions and Benefits (Northern Ireland) Act 1992 (under which other parts of the implementing suite of subordinate legislation has been made) there is no provision for mixing procedures to which the subordinate legislation is subject; and the orthodox view in this and neighbouring legislatures is that it is at the very least undesirable to mix procedures (even if, theoretically, elements of the subordinate legislation could be split). For the future, the Department will consider addressing the matter in primary legislation. In the meantime, it regards this as a drafting defective in parts of the subordinate legislation, but one that does not fatally flaw the subordinate legislation in terms of vires or operation, and I would share that view.

The Social Security Contributions and Benefits (Northern Ireland) Act 1992 (Application of Parts 12ZA and 12ZB to Adoptions from Overseas (Amendment) Regulations (Northern Ireland) 2015 (S.R. 2015/88)

I draw the attention of the Committee for Employment and Learning and the Assembly to the above-mentioned Regulations on the ground they were laid in breach of the 21-day rule, explained by the Department for Employment and Learning. They form part of the large suite of subordinate legislation to implement the Work and Families Act (Northern Ireland) 2015.

They provide for new rights for parents expecting a child to be born or placed for adoption after 5 April 2015, and certain notices (generally 8 weeks, so far as is possible) need to be given by parents in advance of that. In addition, the system is intended to work in tandem with the corresponding regime in Great Britain which was in place earlier (both in terms of primary and subordinate legislation). Accordingly, it seems that the Department's explanation is reasonable. These regulations were generally made on 2 March 2015, laid on 12 March 2015 and came into operation on 15 March 2015. They could perhaps have been laid slightly earlier, but the Department was clearly working under great pressures given the sheer volume of the provisions. S.R. 2015/146 was made and laid on 12 March 2015 and came into operation on 15 March 2015.

The Teachers' Pensions (Miscellaneous Amendments) Regulations (Northern Ireland) 2015 (S.R. 2015/126)

6. I draw the attention of the Committee for Education and the Assembly to the Teachers' Pensions (Miscellaneous Amendments) Regulations (Northern Ireland) 2015 (S.R. 2015/126) on the ground they were drafted defectively in one respect, acknowledged by the Department of Education. Regulations 13 and 25 make further provision in the Teachers' Pensions Scheme Regulations (Northern Ireland) 2014 (S.R. 2014/310) for scheme valuation and employer cost cap. Paragraph 3 of new Schedule 4 to the 2014 (inserted by regulation 25) contains a reference to margins specified by the Department of Finance and Personnel in directions under section 12(5) of the Public Service Pensions Act (Northern Ireland) 2014. But section 12(5) provides for regulations made by DFP, not directions. The Department has acknowledged this and intends to amend it at the first available opportunity, which seems satisfactory.

The Maternity Allowance (Curtailment) Regulations (Northern Ireland) 2015 (S.R. 2015/149)

The Statutory Maternity Pay (Curtailment) Regulations (Northern Ireland) 2015 (S.R. 2015/150)

7. I draw the attention of the Committee for Social Development and the Assembly to the above-mentioned Regulations on the ground they were laid in breach of the 21-day rule, explained by the Department for Social Development. They form part of the large suite of subordinate legislation to implement the Work and Families Act (Northern Ireland) 2015, already mentioned at paragraphs 4 and 5. These Regulations were not able to be made until after S.R. 2015/93 and S.R. 2015/94 were made by DEL (on 2 March 2015). The DSD Regulations were made and laid on 11 March 2015 and came into operation on 15 March 2015 to match (wisely, it seems to me) the commencement of the DEL Regulations. Accordingly, it seems to me that the Department's explanation is reasonable.

The Public Service Pensions Act (Northern Ireland) 2014 (Judicial Offices) Order (Northern Ireland) 2015 (S.R. 2015/161)

8. I draw the attention of the Committee for Justice and the Assembly to the Public Service Pensions Act (Northern Ireland) 2014 (Judicial Offices) Order (Northern Ireland) 2015 (S.R. 2015/161) on the ground they were laid in breach of the 21-day rule, explained by the Department Justice. They were made on 10 March 2015, were laid on 18 March 2015 and come into operation on 1 April 2015. In this case the Department, very candidly, pointed to an administrative oversight, apologised and indicated that it would learn from the experience. In the circumstances that seems reasonable.
