The meeting began in closed session at 2.00 pm.

1. Northern Ireland Public Service Ombudsperson Bill

The Committee considered matters relating to the draft Northern Ireland Public Service Ombudsperson (NIPSO) Bill, and in particular concerns raised by the Northern Ireland Office regarding the operation of clause j81 - the disclosure of information. At the meeting of 14 January 2015 the Committee agreed, by majority, to delay taking action on the letter from the Northern Ireland Office, dated 17 December 2014, until the next scheduled meeting on 21 January 2015.

The Committee considered a proposed three-stranded approach to dealing with the matter raised by the Northern Ireland Office, whilst making the necessary arrangements for the introduction of the Bill to the Assembly. The Committee noted a

copy of the letter from the Chairperson to the Secretary of State requesting formal consent on relevant provisions before the Bill is submitted to the Speaker for introduction.
