The meeting began in closed session at 2.00 pm.

1. Northern Ireland Public Service Ombudsperson Bill

Mr Hicks and Mr McMillen joined the meeting at 2.00pm

The Committee returned to the policy concern regarding clause 41 of the draft NIPSO Bill, highlighted by the Secretary of State in relation to formal consent to the introduction of the NIPSO Bill; and considered the drafting options that had been requested to inform its deliberations. - *Agreed:* The Committee agreed that the Bill team would liaise with the Secretary of State's officials on the draft wording for a provision in the Bill that the NIPSO will agree a memorandum of understanding with the Secretary of State regarding the exercise of their functions in relation to clause 41.
- *Agreed:* The Committee agreed that, provided no technical issues arose with the draft wording, the Chair would write formally to the Secretary of State with an updated Bill and Explanatory and Financial Memorandum to seek formal consent for the introduction of the Bill; and to the Speaker requesting permission to introduce the NIPSO Bill and Ombudsman and Commissioner for Complaints (Amendment) Bill.
