# Constituency Casework Guide: Sources of Funding for the Voluntary and Community Sector

The purpose of this constituency casework guide is to signpost MLAs and their staff to some of the different types of public, charitable and corporate funding opportunities that may be available to local voluntary and community sector organisations. An electronic copy of this leaflet is available on the Research and Information Service (RalSe) page of the Assembly Intranet (AssISt).

Whilst it is not possible to provide a definitive list, as there are hundreds of different sources of grant aid that change constantly, links are provided to key comprehensive funding databases such as NICVA's <u>GrantTracker</u> toolkit and the <u>Northern Ireland Government Funding Database</u> which are regularly updated with funding opportunities. While every effort has been made to ensure that the information in this guide is up-to-date, please bear in mind that funding schemes and webpages change frequently.

Local community and voluntary groups are advised to make the most of social media. The majority of funders use social media to post funding opportunities. Therefore it is an excellent source for up-to-date funding, advice and information.

### 1 NICVA's GrantTracker

<u>GrantTracker</u> is a website dedicated to sourcing grants and fundraising opportunities for charities, clubs and community groups in Northern Ireland. It is a subscription-based database maintained by the Northern Ireland Council for Voluntary Action (NICVA). An annual subscription to the database costs £145 (with a £45 discount for NICVA members) or a monthly subscription of £40. GrantTracker provides a <u>free to access</u> weekly news bulletin with a summary of funding initiatives.

The Northern Ireland Assembly Research and Information Service (RalSe) has a subscription to GrantTracker. MLAs and their staff may access this through the RalSe pages on the Assembly intranet (AssISt) – a password and username is available. # **2 Volunteering Support**

<u>Volunteer Now</u> is the lead organisation for supporting and promoting volunteering in Northern Ireland. It offers <u>advice and information</u> to organisations seeking to recruit volunteers and how to effectively integrate volunteers into the organisation. It also provides <u>training</u> on issues such as safeguarding and risk assessment and <u>webinars</u> on topics such as 'Involving Volunteers in Response to COVID-19'. Volunteer Now also publishes information funding opportunities in its '<u>Latest News</u>' section.

The <u>Community Foundation</u> Northern Ireland are an independent grant making trust. The '<u>News'</u> section of the website and its Twitter feed provides information on its latest funding opportunities for voluntary and community groups. The website also provides useful advice and information on <u>applying for a grant</u>.

# The Government Funding Database

The <u>Grant Finder facility</u> on the Northern Ireland Government funding database can be used to locate available funding from government departments and local councils. The website also provides summary information on the financial support that has been awarded to each voluntary and community organisation.

To locate open funding grant programmes for each department, click on the link above, tick "Funding Source", and this will provide a drop down menu for each department and Local Council.

# European Cohesion Policy Programmes (2014-2020)

The last round of European Cohesion Policy Programmes ran from 2014-2020. The <a href="Department of Finance website">Department of Finance website</a> provides an overview of the number of European Structural and Investment Programmes that Northern Ireland has benefited from.

Please note that due to the UK leaving the EU, the UK will not be part of the next round of funding for the Rural Development Programme (2021-2027).

# PEACE PLUS (2021-2027)

PEACE PLUS is the successor programme to the PEACE IV and INTTEREG programmes that finished in 2020. PEACE PLUS will fund activities that promote peace and reconciliation and contribute to the cross-border economic and territorial development in Northern Ireland and the border region of the Republic of Ireland. The programme framework will include six guiding themes: Building peaceful and thriving communities; Delivering economic regeneration and transformation; Empowering and investing in young people; Healthy and inclusive communities; Supporting a sustainable future; Building and embedding partnership and collaboration.

The programme is currently at an advanced stage of preparation and will be managed by the Special EU Programmes Body (SEUPB)<sup>3</sup>.

# 7 Funding from charities and corporate organisations

In addition to public funding, a wide range of charities, philanthropic and corporate organisations provide grants for a variety of community projects. The NICVA <a href="GrantTracker website">GrantTracker website</a> is dedicated to finding these fundraising and grant opportunities. This section provides an overview and links to some of the funding which may be accessed by local voluntary and community organisations. This is not intended to be fully comprehensive but rather provides examples of the variety of funding that may be available.

Voluntary and community groups may wish to check the websites of these organisations on a regular basis or follow their social media to keep up-to-date with funding opportunities.

# The National Lottery Community Fund

The <u>National Lottery Community Fund</u> is the largest community funder in the UK. Each year millions of pounds of The National Lottery's good causes money is distributed to community and charitable projects.

Specific funding available for **Northern Ireland**:

The National Lottery Awards for All Northern Ireland: offers grants of £300-£10,000 for projects that bring local people together to make positive changes in their community. Applications are welcomed from constituted voluntary or community organisations, schools, and statutory bodies. The funding is for projects that will run for 12 months or less.

Funds can be used for – Equipment, one-off events, small land or building projects, staff costs, training costs, transport, utilities/running costs, volunteer expenses

Deadline - Ongoing

People and Communities: offers grants of £10,000-£500,000 to support project ideas that "come from the community...making it stronger and ready for the future". Applications are welcome from constituted voluntary and community organisations and social enterprises. The funding is designed for projects that will run for between 1-5 years.

Funds can be used for – Staff salaries, training, volunteer expenses, equipment, premises costs, evaluation, overheads

Deadline - Ongoing

Empowering Young People: Offers grants of £10,000-£500,000 for projects that work with young people (between the ages of 8-25 years old). Young people must be involved in the planning and delivery of the project. Applications are welcomed from constituted voluntary or community organisations, and social enterprises. The funding is available for projects that will run for 1-5 years.

Funds can be used for – Staff salaries, training, volunteer expenses, equipment, premises costs, evaluation, overheads

Deadline - Ongoing

Dormant Accounts Fund: Offers grants up to £100,000 to support the voluntary, community and social enterprise (VCSE) sector to be more resilient and prepared for the future by funding activity that increases capacity and sustainability. These funds are *not* derived National Lottery Activity. However, under Section 22 of the Dormant Bank and Building Society Accounts Act 2008, the National Lottery Community Fund will distribute funding, under the direction of the Department of Finance.

Funds can be used for – Will not fund capital refurbishment, building purchases, loan repayments or building works

### General UK funding:

<u>Growing Great Ideas</u>: A new programme to support initiatives that focus on ecologies, platforms, ecosystems, assemblages, networks and constellations. The minimum grant size is £150,000 and the minimum length is two years (can fund for up to ten years in some circumstances).

Funds can be used for – Staff salaries, development work (includes training and upgrading equipment), transport, utilities/running costs, volunteer expenses, equipment, capital costs (if demonstrated to benefit longer term ecology)

Deadline - Ongoing

<u>Climate Action Fund</u> – **Round 2**: Offering two types of funding during round 2: Development funding - £150,000 maximum; Full awards - £1.5 million maximum. Funding is available for medium- and large-scale projects that address waste and consumption.

Funds can be used for – Staff costs, volunteer expenses, general project costs, engagement activities, learning and evaluation, utilities/running costs, organisational development, management costs, some capital costs (including

purchasing equipment, buying/leasing/refurbishing/developing land and building)

Deadline - proposals by 8th April 2021

The National Lottery provides help for <u>applying for funds</u> and offers a monthly <u>newsletter</u> that shares funding opportunities and funding application help.





# The Community Foundation for Northern Ireland

The Community Foundation for Northern Ireland is an independent, grant making trust which awards funding for a range of organisations across Northern Ireland including those which are involved in education, health, housing, the arts, social justice, employment, peace and reconciliation.

The Foundation manages a number of funds, and funding criteria for each varies. The Community Foundation for Northern Ireland provides information on <u>current funding</u> <u>opportunities</u>, <u>advice on making a successful grant application</u> and <u>Frequently Asked</u> Questions.

### Alec Dickson Trust

The Alec Dickson Trust provide grants for up to £500 for individuals aged 30 and under or from small groups of young people, to support volunteering or community services to those most marginalised by society. They provide information on <a href="What We Fund">What We Fund</a>, <a href="Frequently Asked Questions">Frequently Asked Questions</a> and <a href="Top Tips">Top Tips</a>. Funds can be used for – Equipment, project costs

### **ASDA** Foundation

The ASDA foundation offers 3 grant schemes for good causes and community groups; Supporting Communities Grant (£250-£750), Transforming Communities and Improving lives grant, the Green Token Giving programme (£500 for winner, £200 runner-up). Further information is available online.

# **AVIVA Community Fund**

The AVIVA Community Fund provides funding up to £50,000 for projects on building community resilience and financial capability and inclusion. Applications are posted on Crowdfunder and reviewed quarterly. Further information including a step-by-step application guide and submission support are available online.

Funds can be used for – Materials and equipment, volunteer expenses, training costs, activity costs

Deadline – Ongoing (applications reviewed quarterly, next deadline 7<sup>th</sup> April 2021)

### **BBC Children in Need**

BBC Children in Need provides a number of main grants and small grants as well as an emergency essentials programme that supports children and young people living in severe poverty. Further information is available for <u>eligibility criteria</u>, <u>application</u> <u>process and upcoming funding programmes</u>. They also provide a guide to <u>project planning</u> and <u>Frequently Asked Questions</u>.

# Comic Relief

Comic Relief provides funds registered charities that share their aspiration of a "just world free of poverty". Grants are available to charities that have an annual turnover between £250,000-£10m. # Community Finance Ireland

Community Finance Ireland (formerly Ulster Community Investment Fund) is a social enterprise charity than operates across the island of Ireland. They provide loans to other third sector organisations to support sport, community and social enterprise projects. Loans range from £10,000-£600,000 with loan rates between 4%-8%. Information on previous and currently supported loans, loan information and the application process can be found online.

Loans can be applied for – Purchase, construction or renovation of buildings, equipment purchasing, bridging funding gaps, restricting existing debt, working capital

# Community Relations Council

The Community Relations Council is an arm's length body of the Northern Ireland Executive Office with the core aim of promoting a peaceful and shared society based on reconciliation and mutual trust. They offer a range of funding schemes including; Community relations/Cultural diversity, Core funding, Media grant, and Publication grant.

- Community relations/Cultural diversity: Offers grants of up to £10,000 for organisations to develop their capacity to engage in community relations work and to enhance community relations.
- Core funding: Provides support for organisations which are considered of strategic importance in promoting community relations in Northern Ireland. 2021-2022 funding allocation ~£700,000 (subject to the Executive Office approval)
- Media grant: Aims to commission media projects which focus on the engagement of civil society to underpin peace building and/or support the development of a more diverse society in-line with the <u>Together: Building a</u> <u>United Community Strategy</u>. Total funding available £15,000, anticipates making individual awards between £3000-£5000.

 Publication grant: Aims to encourage the production and dissemination of publications that will contribute to greater understanding and better community relations in Northern Ireland.

Funds can be used for – Varied (see individual grant schemes)

Deadline – Currently closed (CR/CD due to re-open 1st April 2021)





# Co-op Local Community Fund

Funds for community projects are provided via 1% of what shoppers spend on selected own-brand products and services. The Co-op Local Community Fund will choose up to 3 projects to fund for up to 12 months. Applications are currently closed but will open again in Spring 2021. Further information including guidance and contact details are available online.

Funds can be used for - Materials and equipment, activity costs

Deadline – Check website for announcement (Spring 2021)

### **DPD Eco Fund**

The DPD Eco Fund is funded by their circular economy initiatives. The scheme has been operating since January 2020. Anyone can apply for the DPD Eco Fund for grants of up to £2000 to support green projects, but schools and educational facilities are particularly encouraged to apply. Further information is available online.

Funds can be used for – Green initiatives (previously has funded purchasing of equipment)

Deadline - Ongoing

### **Enkalon Foundation**

The Enkalon Foundation has an annual budget of around £200,000, part of which is used to support charities and community groups in Northern Ireland in meeting their core objects through the General Fund. The Enkalon Foundation is interested in the advancement of education, health, citizenship, community development, arts, culture, heritage, science, amateur sport, animal welfare as well as the relief of those disadvantaged in society. The Foundation do not normally offer grants to playgroups, PTA's, senior citizens groups or sporting groups outside the former Antrim borough area or to individuals or for medical research or for travel or projects outside Northern

Ireland. Grants of up to £6,000 are awarded (average £1000), with applications reviewed quarterly. For further information, including application deadlines, visit their website.

Funds can be used for – No information provided

Deadline – Ongoing (Applications reviewed in March, June, September and December)



# The Fermanagh Trust

The Fermanagh Trust is an independent community based foundation that supports local communities and groups across County Fermanagh. The Trust aims to promote positive relationships across civil society, enhance people's lives and promote sustainability. They administer a wide range of grant programmes and funds, information on these can be found online.

Funds can be used for – Varied (see individual grant schemes)

### Garfield Weston Foundation

The Garfield Weston Foundation is a grant-giving charity that supports UK registered charities and organisations working within the UK in the areas of welfare, youth, community, arts, faith, environment, educations, health and museums and heritage. The foundation offers two grant programmes; Regular grants and Major grants.

- Regular grants: Offers grants below £100,000.
- Major grants: Offers grants of £100,000 or more. Major grant applications are reviewed during board meetings (meet eight times in a year). If you are considering a major grant application, you need to send a one page summary to the grant assistant (cmolloy@garfieldweston.org) outlining what the grant is for, the total cost and fundraising target. It is expected that those applying for major grants, have an annual or project income in excess of £1m.

The Garfield Weston Foundation provides <u>application guidelines</u>, <u>frequently asked</u> <u>questions</u> and an <u>eligibility quiz</u>. Further information and <u>how to apply</u> can be found <u>online</u>.

Funds can be used for – Capital, revenue and project work

### Groundwork

Groundwork is a federation of charities that enable practical community action on poverty and the environment across the UK. Groundwork has dedicated Northern Ireland team who work with communities to enhance their "lives, places and prospects, from the ground up". Groundworks Northern Ireland provides grant management to national and local governments, public sector agencies, corporate partners and charitable trusts. ### Halifax Foundation for Northern Ireland

The Halifax Foundation for Northern Ireland is one of four independent grant making trusts covering England & Wales, Scotland, Northern Ireland and the Channel Islands. The trusts are shareholders in Lloyds Banking Group and together receive 0.5% of the Group's pre-tax profits. The Halifax Group for Northern Ireland maintains that it is committed to supporting underfunded, grassroots charities that enable people, especially disabled and disadvantaged people, to play a fuller role in society. Funding applications are accepted from organisations with recognised charitable status. The Halifax Foundation for Northern Ireland currently operate a Small Community Grant Programme that funds projects that either support social and community needs or education and training. The average grant for 2020 was £3,925.

Funds can be used for – Materials and equipment, salary contributions, overheads, transport costs, volunteer expenses, training costs, activity costs, refurbishments, disability access

# Henry Smith Charity

The Henry Smith charity is an independent grant making trust that offers support to people and communities to bring about positive change. There are two grant schemes open to Northern Ireland; Improving Lives and Strengthening Communities.

- Improving Lives: Offers grants of between £20,000-£60,000 to small and medium sized organisations in the UK. Grant lengths should be between 1-3 years.
- Strengthening Communities: Offers grants of between £20,000-£60,000 to small community based organisations that are working in the most deprived areas of the UK (15% most deprived for Northern Ireland). Grant lengths should be between 1-3 years.

# The Honourable Irish Society

The Honourable Irish Society is a self-funded, cross-community charitable organisation that works for the benefit of County Derry/Londonderry. The society typically makes around 100 small grants a year to organisations or individuals in the voluntary sector. They are particularly interested in funding projects that address; alcohol and substance misuse, disabled people, disadvantaged young people, domestic and sexual violence, the elderly, homelessness, prisoners and ex-offenders and the visually impaired. The society currently has two funding schemes; County Derry/Londonderry and Northern Ireland.

- County Derry/Londonderry: Offers grants of up to £1000 to organisations or up to £250 to individuals for projects within County Derry/Londonderry.
- Northern Ireland: Offers grants of between £1000-£2000 to organisations for projects in Northern Ireland (excluding County Derry/Londonderry

Funds can be used for – Specific projects or items of equipment, particularly of a more permanent nature.

Deadline – Ongoing (Grants are allocated in February, April, June and October)





### The Ireland Funds

The Ireland Funds is a global philanthropic network that promotes and supports peace, culture, education and community development across the island of Ireland and among the Irish communities globally. The Ireland Funds offer two grant schemes; Small Grants and Flagship Awards.

- Small Grants: Offers grants up to €10,000 for projects that encompass at least one key programme area; Community development, Education, Arts and Culture, Peace and Reconciliation.
- Flagship Awards: Offers grants for core funding, capacity building or programme costs within at least one of the key programme areas; Community development, Education, Arts and Culture, Peace and Reconciliation.

### John Moores Foundation

The John Moores Foundation provides funding to local community organisations to carry out charitable work in Northern Ireland and Merseyside. The Foundation aims to improve the social conditions and quality of life to people facing barriers. The Foundation priorities small, grassroots and volunteer-driven organisations. The average grant awarded during 2019-2020 was £5000. To gain access to the application, you must first contact the foundation. Further information can be found online.

Funds can be used for – Core running costs, volunteer expenses, education and training costs, venue and travel costs, one-off project costs, materials and equipment

# Joseph Rowntree Charitable Trust

Provides grant funding for projects working in five areas – peace and security; power and accountability; rights and justice; sustainable future; and Northern Ireland. While trustees are open to funding a range of different organisations, it generally funds work that is "about addressing the root causes of problems rather than delivering services or alleviating immediate needs". They provide a step-by-step application guide, the next

Funds can be used for – Offers unrestricted (core) grants and project restricted grants

# Kellogg's Breakfast Club Grants Programme

Trusthouse offer two grant programmes; Small Grants and Major Grants.

- Small Grants: Offers single year grants between £2000-£10,000 for projects and organisations located in an urban area in the bottom 15% most deprived areas or in a rural area located in the bottom 50% (<a href="https://deprivation.nisra.gov.uk/">https://deprivation.nisra.gov.uk/</a>).
- Major Grants: Offers 1) single year grants between £10,000-£100,000; or 2) multi-year grants (maximum 3 years) up to £100,000. Projects and organisations must be focused on family support and either be located in an urban area in the bottom 15% most deprived areas or in a rural area located in the bottom 50% (<a href="https://deprivation.nisra.gov.uk/">https://deprivation.nisra.gov.uk/</a>).

### The Tudor Trust

The Tudor Trust is an independent grant-making trust that supports voluntary and community groups in the UK. # Sport Northern Ireland

Sport Northern Ireland is a public body for the development of sport in Northern Ireland. Sport NI is distributes funds on behalf of the Exchequer and the National Lottery. Sport NI provides funding through numerous schemes including;

- <u>Facility Fund</u>: Announced a new plan to invest £17.5m of it National Lottery funding into sports facility projects over the next five years. Investments can be for single, multi or performance facilities.
- Sports Hardship Fund: Sport NI in partnership with the Department for Communities offered grants to help clubs maintain facilities, most recently phase 3 offered grants for aid during the lockdown.
- Supporting Sport to Build Back Better: Long term strategic response to the impact of COVID-19 on sport across Northern Ireland. The programme will provide a multi-strand approach to support the sporting system, and will include open grant schemes (many launched January 2021).
- Athlete Award Programme Contribution towards the essential personal living costs of an athlete, to enable them to train in order to maximise their potential.

# **Sport Relief**

Cash4Clubs has combined with the charity <a href="Made By Sport">Made By Sport</a> to offer grants of £2021 in unrestricted support, through the 'Clubs in Crisis' fund in response to COVID-19. The Clubs in Crisis fund was set up to help directly support grassroots community sports clubs and organisations that work with young people. The campaign has Small Grants Scheme that provides funds of between £500-£5000 to support volunteer and community groups, schools and third level education organisations, youth groups and sports clubs in Northern Ireland. Projects should; improve the health and wellbeing of communities, improve and/or maintain public spaces, reduce littering and dog fouling, improve the local environment, contribute to the development of civic pride. # 11 Advice and guidance on making a funding application

Writing a funding application may seem daunting, particularly for smaller organisations and groups, but there is an abundance of advice and guidance available. Some examples are set out below:

### Tips for finding funding opportunities

- 1. Contact NICVA for advice and information on funding opportunities.
- 2. Search for funding opportunities via <u>GrantTracker</u> (access for MLAs and constituency staff only is provided on the Assembly Intranet).
- Consider encouraging voluntary and community groups to sign up to the social media of potential funders such as public bodies, charities and corporate bodies

   in this way they can gain instant access to information on the latest funding opportunities.
- 4. Contact your local council or check your local council website for information on council funding opportunities. Ask your local council if they are providing funding workshops or sessions.
- 5. Encourage community and voluntary organisations to 'think outside the box'. For examples, sports clubs primarily apply for funding specifically for sports but could also be encouraged to apply for funding opportunities that are linked to e.g. health and wellbeing, tackling social deprivation, or providing opportunities for people with disabilities etc.

- 6. Local community groups could consider how they can work with other groups as part of a network in order to attract funding and/or could contact other groups who have been successful at attracting funding in order to gain insights into making a successful funding bid.
- 7. Support your grant applications with statistics on need within your local areas the Northern Ireland Assembly Research and Information Service publish statistical profiles for each constituency. The Northern Ireland Statistics and Research Agency (NISRA) provides filtered statistical information on a range of issues and geographic area.
