# EUROPEAN PRIORITIES 2012-13 IMPLEMENTATION REPORT

#### <u>Background</u>

The Executive published its 2012-13 European Priorities on 28 May 2012. These maintained the thematic approach established in previous years, identifying 55 objectives to be pursued by the four cross-departmental sub-groups of the Barroso Taskforce Working Group (BTWG):

- Competitiveness and Employment;
- Innovation and Technology;
- Climate Change and Energy; and
- Social Cohesion.

These objectives were translated into 125 individual targets for delivery across the year; and published as the 'European Priorities 2012-13 Implementation Plan'.

#### **Summary**

Thematic Sub-Groups have assessed progress by adopting the Programme for Government (PfG) methodology which assigns a 'Green', 'Amber/Green', 'Amber' or 'Red' rating.

Thematic Sub-Groups report that 111 targets (88.8%) were fully achieved with a further 9 targets (7.2%) substantively achieved. Only 5 targets were not met. A full list of the targets and their ratings is provided (Section 2), along with a detailed exceptions report for each target not fully achieved within the year (Section 3).

# 1. KEY ACHIEVEMENTS

<u>Policy</u>

- Influenced the draft Trans-European Network Transport (TEN-T) and Connecting Europe Facility (CEF) regulations securing amendments which improve our future funding opportunities and avoid infrastructure upgrades which were inappropriate to the needs of the region, potentially saving around £13.5bn;
- Persuaded Commissioner Almunia that large companies in 'Category C' areas should continue to be eligible for Regional Aid post 2013;
- Lobbied for further Peace funding resulting in a separate statement in the MFF agreed by Heads of State of €150 million for a PEACE IV programme;
- Applied for EU 'Reference site' status for the region in respect of its expertise in 'Active and Healthy Ageing';
- Agreed a 'Connected Health and Prosperity Strategic Action Plan' for the region and established a Northern Ireland Connected Health Eco-System to promote greater collaboration among our public sector, private companies and our universities;
- Became the first UK region to be 'peer reviewed' regarding innovation policy development at a European Commission Smart Specialisation workshop;
- Developed a new regional strategy for older people's issues in consultation with the European Commission;

<u>Networks</u>

- Hosted visits to the region by three EU Commissioners and the Chair of the European Parliament's Transport Committee;
- Secured joint funding from the European Commission to hold a conference on Smart Specialisation in 2013;
- Created a 'Justice Network' to promote EU funding opportunities for organisations working within this sector;
- Hosted a major EU Funding workshop for a wide range of stakeholders, including local and central government, research establishments, NGOs and SMEs;
- Along with Queens University Belfast and the University of Ulster, developed a new European Centre for Delivering Social Change.
- Helped organise and run a number of European engagement programmes for local organisations in Brussels, including, the Arts Council, the Irish Football Association, Autism NI and Where is My Public Servant;
- Appointed a Horizon 2020 manager to lead on preparations for the next EU programme for research and development;
- Hosted 11 Culture events, including musicians, artists, authors, poets, a film and two plays; in the Executive's Brussels Office, continuing to raise our Culture Profile in Brussels;
- The PSNI continued to build its reputation in Europe, submitting two major lead applications in November 2012 being invited to participate as a partner in 10 others.

#### Funding

- Secured a regional drawdown total of €55,739,264 from Framework Programme 7 (FP7) since the commencement of the current funding period.
- Latest available FP7 figures (November 2011 to July 2012) reveal an additional 19 successful North/South FP7 applications in this period. These have a total value of €20.5m (representing a 51% increase in this short time).
- Provided partnership/support for a programme of 9 significant EU funded projects (INTERREG IVB, LIFE+, FP7 and DG MARE) with a total value of some £12m of which £3.3m will be directly drawn down over the next 3-4 years by partners in NI;
- Submitted three successful applications for TEN-T funding resulting in the award of circa €5m;
- Secured TEN-T funding for a regional network of 'eCar' charging points under the Electric Green Highways Project, which provides the first cross-border interoperable electric car charging infrastructure in the EU;
- Supported NIACRO in its successful application to the 'Solid Basis for the Future of Young Male Offenders' project in the Daphne III programme, in which they will work with 8 partners, drawing down €33,000 over 2 years.
- Supported the PSNI in its submission of two major lead applications;
- Supported Sport Northern Ireland and the Arts Council for Northern Ireland in funding applications;
- Secured an FP7 research project on Smart Specialisation in 2013;
- Provided new support for agriculture-based SMEs wishing to engage in EU research programmes;
- Established a small grant scheme with the Arts Council to support outward visits by regional groups to learn best practice in establishing funding projects;
- Successfully submitted an INTERREG IVA application for circa £2.4m of funding towards the redevelopment of Portadown Railway Station;
- Submitted a successful application for £5.8m funding from the Competitiveness and Employment Programme for replacement of Goldline and Metro Fleet;


