I have had a look over the updated report and most of the points have been addressed. However, because the NPCs have not been attached it is difficult to determine exactly what years have been used as the basis for the bridge replacement though the assumption of 'replacing when necessary' is what I was hoping to see. Given this, and the fact that the bridge replacement will not ultimately affect option ranking, I am content to let this go and am therefore happy for the EA to go to DFP. Word of warning though, because the project is so expensive I would expect DFP to come back with a long list of comments - hopefully none of which will be too difficult to deal with.
