The meeting commenced in open session at 10.04 a.m.

1. Apologies

Apologies were noted as above.

The Chair welcomed Adrian McQuillan to the Committee.

Agreed: The Committee agreed to write to Gordon Lyons to thank him for his service to the Committee.

2. Draft Minutes

3. Chairperson's Business

The Chair advised members that he met with the Chairperson of the NIHE, Donald Hoodless, on Wednesday 7 October 2015, to discuss key issues including the social housing reform programme, asset management, the Journey to Excellence programme and initiatives including the social enterprise strategy.

4. Matters Arising
