The meeting opened to the public at 10.10am.

1. Apologies

Apologies were as noted above.

2. Draft Minutes

Agreed: The draft minutes of the meeting held on 3 April were agreed.

3. Chairperson's Business

There was no Chairperson's business.

4. Matters Arising

- 4.1 The Chairperson noted that, following today's regular business, the Committee would convene in closed session to review evidence gathered to date in relation to its Inquiry.
- 4.2 The Chairperson noted that a number of Committees are not meeting on the week commencing 19 May 2014 due to elections and suggested to members that the Committee could convene earlier that week depending on plenary business. He indicated he would bring this back to Committee after the Easter recess when the situation regarding plenary business was clarified.
- 4.3 The Chairperson noted that the Department has indicated that it is ready to publish the Pensions Bill EQIA, unless the Committee wishes to make comment. *Agreed:* The Committee agreed to submit a nil response to the Department in respect of the Pensions Bill EQIA.

- 4.4 The Chairperson noted that the minutes for the meeting of 20 March 2014, agreed at last week's meeting, contained an omission of one of the agreed pieces of subordinate legislation. An amended version of the minutes was considered by the Committee. *Agreed:* The Committee agreed to the minutes as amended.
- 4.5 The Committee considered a letter from Exorna expressing concern about the unresolved negotiations between the NI Housing Executive and contractors and the impact this was having on other businesses.
 Agreed: The Committee agreed to write to the Department to express its concern over this matter and urge a swift resolution of negotiations.
- **5. Financial Inclusion including work with Credit Unions Departmental Briefing** The following officials joined the meeting at 10.17am:

The officials briefed the Committee on the planned delivery of the Financial Capability Strategy – an outworking of PfG. They noted that new measures are currently being piloted in Jobs and Benefits Offices in Strabane, Omagh and the Falls Road and also touched on the proposed delivery of targeted support through a Financial Support Service.

The officials briefed the Committee on the reformation of Child Maintenance in Northern Ireland and took questions from Committee members. The officials agreed to provide the Committee with written clarification on a number of issues including the amount of money owed in arrears.

7. SL The Business Improvement Districts (General) Regulations (NI) 2014

Agreed: The Committee was content for the Rule to be made.

8. SL The Social Security (Invalid Care Allowance) (Amendment) Regulations (Northern Ireland) 2014

A member lodged concern that the stated increase was the very minimal possible and there ought to be a sliding scale in benefits paid out to carers, rather than an absolute threshold earnings value. It was noted that carers often earn a fraction of the minimum wage whilst providing significant savings to the government.

Agreed: The Committee was content for the Rule to be made.

9. SR 102/2014 Maternity Allowance (Wife or Partner of Self-Employed Earner) Regulations (NI) 2014

The Committee had no objection to the Regulations and the Chairperson read the following into the record:
