The meeting commenced in closed session at 10.05am.

Mickey Brady MLA left the meeting at 11.21am.

The Chairperson declared the meeting open to the public at 11.45am.

Paula Bradley MLA and Fra McCann MLA declared interests in relation to item 5 on the agenda as members of trade unions.

1. Apologies

2. Draft Minutes of the meeting held 3 October 2013

3. Chairperson's Business

- 3.1 The Chairperson noted that Dolores Kelly MLA has replaced Mark H Durkan MLA on the Committee and welcomed Mrs Kelly to the Committee.
- 3.2 The Chairperson noted that Unison have provided the Committee with a report on Equality of Opportunity and Sustainable Development in Public Sector Procurement available to members on request.
- 3.3 The Chairperson advised that the Law Centre has asked for Committee participation at its AGM, with an opportunity for stakeholder engagement on the issue of welfare reform and social security. The Chairperson noted that he had been asked to give an introduction on behalf of the Committee and asked for members to indicate whether they intend to take part.
- 3.4 The Chairperson noted that the Committee for OFMDFM will be holding a roundtable stakeholder event on Social Enterprise Hubs and Nurture Units on 13 November and have asked for participation from members of the Committee for Social Development. He asked members to indicate if they will be taking part and noted that the Clerk has written to the Department on behalf of the Committee to ask that it provides representation at the event.
- 3.5 The Chairperson reminded members that they would be receiving evidence on the Pavement Cafés Bill from stakeholders today and that each member had been provided with a Bill folder and a clause-by-clause table.

The officials briefed the Committee on issues facing the Community and Voluntary Sector, indicating that they were seeking to determine a way forward for engagement with the Department and the Committee.

The union representatives stated that it is the Government's responsibility to ensure fair treatment of workers in the sector. They reiterated their desire to establish a tripartite forum - including funders, employer organisations and trade unions - to engage with the Department over the issue of fair treatment of workers

The Chairperson noted that the Committee is keen to see progress on this issue and, if it was content, he and the clerk would meet with the union representatives to discuss options to move this issue forward. The Committee agreed that it was content with this approach.

The officials briefed the Committee on their response to the Pavement Cafés Bill, outlining their support of their Bill, but highlighting some issues that caused them concern.

During the course of discussion, the need to clearly define what constitutes a pavement café was raised, as well as that of screening to physically demarcate pavement café areas.

Issues around smoking, alcohol consumption and the definitions of public and private land were also discussed. The officials noted that on the last of those issues, there was potential to employ elements of the legislation on Street Trading – an approach that has been adopted in England.
