The meeting commenced in closed session at 10.04am.

The Chairperson declared the meeting open to the public at 10.47am.

1. Apologies

2. Draft Minutes

3. Chairperson's Business

- 5. SL1 The Social Security (Waiting Days) (Amendment) Regulations (Northern Ireland) 2014 Departmental Briefing

The Committee was content to note the Commencement Order.

7. SR 204/2014 The Pensions (2012 Act) (Transitional, Consequential and Supplementary) Regulations (Northern Ireland) 2014

The Committee had no objections to the Rule.

8. SR 213/2014 The Pensions (2012 Act) (Consequential and Supplementary) Regulations (Northern Ireland) 2014

- **9.3** The Chairperson noted that Fold Housing Association invited members of the Committee to an event in Ballymena on Friday 5 September about *Floating Support for Older People*. A number of members confirmed that they would attend this event.
- **9.4** *Agreed:* The Committee agreed to note the rest of the correspondence as outlined on the correspondence memo.
