The Deputy Chairperson declared the meeting open 10:06am.

1. Apologies

2. Draft Minutes

4. Matters Arising

- **4.1** The Committee noted correspondence from the Department in relation to the Landlord Registration Scheme. *Agreed:* The Committee agreed to schedule a Departmental briefing.
- **4.2** The Deputy Chairperson reminded members that the Committee's report on Phase 2 of the Inquiry was due to be published on Friday 13 March 2015. The Deputy Chairperson noted that unexpected delays had resulted in the Minister receiving the report two working before publication rather than the three as stated in guidance.
