## 1. Apologies

#### 2. Draft Minutes

#### 3. Matters Arising

- **3.1** The Chairperson noted that today's evidence session with Cruse Bereavement Care is the last stakeholder evidence session scheduled in relation to the Pensions Bill and that, following this session, the Committee will agree on how to proceed in its consideration of the Bill.
- **3.2** The Committee noted that the Regeneration Bill is now at Committee Stage. Given the current workload, the Committee discussed the merits of an extension to the Committee Stage.

*Agreed*: The Committee agreed to lay a motion seeking an extension to the committee stage of the Regeneration Bill until 28 May 2015.

*Agreed*: The Committee also agreed to schedule a departmental briefing on the Bill in February.

*Agreed*: The Committee agreed to issue the call to evidence for consideration stage of the Bill.

- **3.3** The Chairperson noted that, following today's briefings, the Committee will convene in closed session to conduct an initial review of evidence in respect of Phase 3 of the Committee's Inquiry.
- **3.4** *Agreed*: The Committee agreed to hold a discussion regarding the issue of stock transfer at Rinmore at the meeting following receipt of information on this matter from the Department.

## 4. Pensions Bill – Briefing by Cruse Bereavement Care

The briefing raised issues in relation to the clauses in the Bill relating to bereavement support payment including the impact of the Bill on widowed parents with dependent children, the duration of Bereavement Support Payments, the conditionality relating to the benefit and the impact on unmarried partners with children.
