# 5. Hospital Parking Charges (Northern Ireland) Act 2022 – proposed amendments

The officials briefed the Committee on the Minister of Health's intention to introduce a Bill that will defer the operational date of the Hospital Parking Charges (Northern Ireland) Act 2022 and his intention to seek Accelerated Passage for the Bill.

The briefing session was reported by Hansard.

#### 7. Victims and Prisoner Bill - Infected Blood Compensation Scheme

interim funding payments to families.
