1. Apologies

2. Chairperson's Business

The Committee further resolves that in carrying out this function the Examiner shall be authorised to report her technical findings on each statutory rule to the Assembly and to the relevant Department, as well as to the Committee itself and to publish her report.”

The Committee noted a memo from the Clerk providing a summary of current subordinate legislation falling under the Department for Communities which is subject to assembly procedure.

11. Correspondence

The Committee noted a correspondence memo.

The Chairperson drew members' attention to an invitation to attend the Cliff Edge Coalition Roundtable event on behalf of the Committee and informed members he would check diaries and confirm attendance via the Committee team.

The Chairperson emphasised that including stakeholders in the work of the Committee is critical to its success in helping deliver outcomes for a range of sectors under the remit of the department.
