**Dear Peter** 

Further to your letter dated 09 January 2025 in relation to the Great British Energy Bill, please see response below which has been cleared by Minister Murphy. This submission contains considerations of discussions with UK Government. It may, therefore, be subject to Freedom of Information exemptions under section 36.

The committee sought clarity on a number of areas.

## How the renewable energy development of the NI coastal seabed by the new energy company will impact on devolved responsibilities.

Offshore renewable energy development requires a seabed lease and relevant consents, all of which are allocated through NI Departments and therefore subject to Minster and Executive clearance as appropriate. Great British Energy (GBE) cannot develop within NI's marine area without seeking the necessary permissions.

The degree of agency that the Executive will enjoy in respect of the allocation of renewable energy development funding by the new energy company in Northern Ireland.

Officials have held broad discussions with the Department for Energy Security and Net-Zero (DESNZ) GBE transition team to explore potential funding allocations and

been given assurances that the organisation will invest in all four nations/regions. It has been agreed that further discussions will take place on how funding arrangements will operate in practice once the company has been set up.

How and when key energy players in NI will be consulted by the new energy company as it implements its strategy.

We understand from DESNZ officials that GBE intends to meet with NI public bodies and other relevant stakeholders to explore potential partnership opportunities.

DfE officials and DESNZ transition team continue to meet regularly regarding updates on the establishment of Great British Energy.

The Committee would also appreciate any related background policy information that the Department can provide as well as clarity in respect of the LCM's progress through the Executive.

Background policy to how the company intends to operate can be found in its founding statement which is available at: <u>Great British Energy founding statement - GOV.UK</u>

Discussions with DESNZ officials up to this point, have focussed on assurances around the interaction of the Bill within the devolved sphere and seeking an amendment to clause 5 aimed at protecting Executive strategic interests in how the company operates.

The Executive is considering whether the legislative consent of the Assembly should be sought on those provisions of the Great British Energy Bill that extend to Northern Ireland. Officials will engage with Assembly Business Office around the scheduling of the debate should this be confirmed.

## **Great British Energy Bill - legislative consent**
