My Records State I was taken in middle of night

No Consent or permission was asked for or needed

Admission records show I was there from [REDACTED]

3 times to try + see me first time she was

refused 2nd time a young girl (not a nun) let

her in and went + got me, she breastfed in the

hallway - she said I was starving this would be

would need to go but not before she asked for

3 punts for seeing me - [REDACTED] paid her 3 punts

(like in [REDACTED] - four bits of money then.)

The 3rd time [REDACTED] came to [REDACTED] would be

[REDACTED] by this time [REDACTED] has persuaded her

He gave her £50 in "~~some~~ fivers" (a months wages then)

he had made a small wooden crib for me

and said we could stay in small house at bottom

of [REDACTED] he told [REDACTED] "go and get the wee

one more won't make any difference"

[REDACTED] arrived at [REDACTED] and asked for her baby

A nun told her your baby is gone (again.)

He was adopted by couple in [REDACTED] she said

(this was in fact a lie as records show I never

left there until [REDACTED]) she sat on step

crying A nun came out and told her to leave

now and never come back or they would call

the [REDACTED] on her

She left that day and it would

be 47 years until she seen me again.

As I said I was in [REDACTED] from [REDACTED] until [REDACTED]

I was handed over by nuns to [REDACTED] welfare on

[REDACTED] I have original paperwork of transfer dated

[REDACTED] both nuns + welfare publicly denied on

TV. Spotlight programme they had anything to do with

my adoption - my original paperwork dated [REDACTED]

Say different they are both lying and I can prove it

I have huge amounts of original documents proving

everything I have said so far - these are all facts

This is all their own paperwork not mine

My adopted Mother kept every in a big envelope

for me all her life in case I ever wanted to

find out who I was

I was placed in their care
on [REDACTED] so I was fostered out till November [REDACTED]

adoption order was granted [REDACTED]

My name was changed to [REDACTED]

The whole adoption was based on lies and subterfuge

My birth mother Signature when I was 14 months old
is fake again I can prove this.

I have a Copy of a form she filled in around [REDACTED]
She wrote in Single letters almost Childlike Even up
to her death in [REDACTED] her writing never changed She
would Send me birthcards in the [REDACTED] I knew her
personally her writing beared no resemblance at all
to the Signature presented to the Court for my adoption
she Could not do joined up writing.

I again have paperwork and Statement from her
husband from [REDACTED] time which puts them both in
[REDACTED] not in [REDACTED] Signing
her parental rights away

The thing is a lie/fake

I can prove all this by official documentation

And Serious flaws in the timelines

I Even have the Solicitor bill for my adoption bbb
