we write today to follow up on our evidence meeting with yourselves On 17th Sep 2025.

We had been asked to send through our follow up of evidence of relevant persons and  
proposed names of further institutions to be added to the list that is on page 29.

Right now, our priorities are focused on the posthumous claim date and standardised  
payment to be amended on this side of the inquiry.

We also would like to prioritise the pathways and practices of our children Born to any  
woman that entered the Institution's in NI .

Also we believe that the full adoption's Systems of today's practices should not be relevant  
in this inquiry.

However, we believe the Chair of the inquiry will have the powers to compel, and can add the following institutions at a later date.

**Workhouses:**

Omagh, Dungannon, Armagh, Antrim, Belfast, Coleraine, Derry, Larne, Lisburn, Lurgan, Magherafelt, Newry, Newtownards.

**Children's Homes:**

St. Joseph's baby home, Dioceses of Down & Connor  
St Catherine's industrial school, Strabane  
Coleshill children home, Fermanagh  
Coney warren children's home, Omagh  
Mourne Drive children's home, Derry ( we believe this was an Industrial school/ Laundry)  
Fort James children's home, Derry  
Nazareth house.  
Nazareth Lodge

Mothers and Children born to them in Private Nursing Homes ni

**Other information:**

In regards to the graves we believe Toni Maguire (Archaeologist) gave a briefing to yourselves on 19<sup>th</sup> June 2024 which was very informative.  
Carrickcruppen and other graves were mentioned during this conversion, 429 infants lay in a mass grave in Milltown Belfast.  
Killeavy grave yard Newry has also a mass grave with token from the GOOD SHEPHERDS NUN'S.  
Sean O'Connell from the independent panel should be able to provide more evidence regarding other work-houses and Institutions and relevant person's to be included .
