The Committee considered SL1 The Recovery of Health Service Charges (Amounts) (Amendment) Regulations (Northern Ireland) 2020 which would apply an inflationary

uplift to the current tariff levels used for the collection of costs incurred by hospitals when treating casualties of road traffic accidents.
