**Dear Kathy** 

Thank you for your letter of 1 July, and the request for further information.

It is important to clarify that the term 'juvenile' is not in common parlance, and is not usually heard in meetings and discussions related to the youth justice service currently. It is rare to hear this language, and I cannot recall encountering such while working on the CYPSP Reducing Offending Regional Sub- Group, the Strategic Framework for Youth Justice Implementation Group, or any other interaction with the Department of Justice or other Justice agencies.

More widely, it appears there remains a lexicon of outdated terminology within historic legislation. For example, I attach here a draft of our note in response to the ongoing consultation around qualifying offences under PACE, highlighting the use of terms 'child pornography' and 'child prostitution', both of which are considered archaic and unacceptable. Please note, this document is in draft format and should not be shared at present. I am happy to provide a copy of our response, once submitted to the Department.

In relation to the use of Live Links in court proceedings, I understand this was discussed by the young people who took part in the workshop with members on 3 July. We believe that Live Links can be used effectively for many young people, who may find the experience of going to court overwhelming. However, for other young people such use may be unhelpful. It very much depends on the individual young person. That is why we argue that the option should be made available to all young people, but that they are supported to make an informed choice on whether to participate via Live Link, or to attend court in person. Their decision should be respected and facilitated.
