## 5. Correspondence

#### **Trevor McKee – Charity Commission for Northern Ireland**

The Committee noted correspondence dated 27 April 2021from Mr Trevor McKee, regarding decision by the Charity Tribunal for Northern Ireland to agree a hearing. The Committee noted that Mr McKee has copied his correspondence to NIAO and the Committee for Communities.

**Agreed:** The Committee noted the correspondence.

#### Nicole Lappin, Chief Charity Commissioner, CCNI

Following on from Mr McKee's correspondence of 27 April 2021 regarding the Charity Tribunal, the Committee noted correspondence dated 30 April 2021, from Nicole Lappin, Chief Charity Commissioner, CCNI, clarifying the Commissioners position on this matter.

The Committee noted the C&AG would be monitoring any wider implications for similar cases in relation to this court ruling.

**Agreed:** The Committee noted the correspondence and C&AG's comments of the potential wider implications for other cases.

#### Mike Brennan AO DfE

The Committee noted correspondence dated 4 May 2021 from Mr Mike Brennan, AO DfE, regarding 'Administration Costs of Covid Disruption Payment Scheme'. Mr Brennan outlined that the 10% allocated to cover any transaction fees incurred per student in administering the Covid Disruption Payment is a <u>nominal cost</u>; and the Department has the right to claim back whatever element of these notional administration costs is appropriate from the universities, once an assessment of the actual costs for each university has been carried out based on audited information.



**Agreed:** The Committee noted the correspondence.

The meeting remained in Open Session at 2.10 pm

#### 6. Ministerial Directions

The following Officials remained in the meeting:

The Committee noted it would be considering three Ministerial Directions today of which two where historical; that is the schemes are closed. The Committee noted the C&AG is looking into the reasons why there has been a delay in a number of Ministerial Directions coming to the Committee from the Department for Economy.

**Agreed:** The Committee agreed to write to Mr Mike Brennan AO DfE to appear before the Committee to discuss a number of issues: the reason for the delay in forwarding the Ministerial Directions to C&AG; to ask for further clarification on recent correspondence in relation to the inquiry into 'Generating Electricity from Renewable Energy'; and to receive an update on the York Street Belfast University Campus.

**Agreed:** The Committee agreed to schedule this into the draft Forward Work Programme.

The Committee noted **a** response dated 6 May 2021 from the Audit Office regarding a query last week from Mr O'Toole on the DoF Ministerial Direction on "Additional Financial Assistance Schemes to make use of the remaining 2020-21 COVID-19 Funding". Mr O'Toole enquired if the £177.9 million expenditure relating to the three



schemes covered by this Direction was the highest amount covered by a single COVID related Ministerial Direction to date.

**Agreed:** The Committee noted the response from Mr Kyle Bingham, Assembly Support Officer, confirming this was the second highest; the other being £294 million regarding DfE £10k Business Support Grant Scheme.

# 1. Ministerial Direction: 'Recognition Payment for Supporting People and Homelessness Sector Frontline staff':

The Committee noted correspondence dated 26 April 2021, from Mr Kieran Donnelly, C&AG regarding a Ministerial Direction – 'Recognition Payment for Supporting People and Homelessness Sector Frontline staff'. The DfC Permanent Secretary wrote to the C&AG on 15 April 2021 to advise that she had sought a Ministerial Direction from the DfC Minister, Deirdre Hargey MLA, on 30 March 2021 to put in place arrangements to make one-off £500 payments to Supporting People and Homelessness sector staff in recognition of the work they have done during 2020-21 at a cost o £2.5 million.

**Agreed:** The Committee noted the Ministerial Direction and that the C&AG will keep this matter under review, as the Audit of the 2020-21 financial statements progresses.

# 2. Ministerial Direction: 'COVID RESTRICTIONS BUSINESS SUPPORT SCHEME' (CRBSS).

The Committee noted correspondence dated 4 May 2021, from Mr Kieran Donnelly, C&AG regarding a Ministerial Direction from the DfE Minister, Diane Dodds MLA, on 20 October 2020 to implement a scheme to provide support to local businesses and address the gaps in the DoF Local Restrictions Support Scheme (LRSS) which did not provide help to businesses that were forced to close but did not pay business rates, for example, hairdressers renting a chair in a salon, driving instructors and mobile beauticians.



The Committee noted\_that the Scheme provides a grant of up to £800 per week for eligible businesses, falling within the central funding envelope, to provide financial support for businesses impacted by Covid.

The Committee noted the Department has stated it provided an email to the C&AG indicating notification had been sent to him on 4 November 2020, however C&AG does not have a record of receiving this email.

**Agreed:** The Committee noted the Ministerial Direction and the relevant papers underpinning the decisions.

**Agreed:** The Committee noted the C&AG will keep this matter under review as the Audit of the 2020-21 financial statements progresses; and that the C&AG is currently investigating why he did not get notification of the MD on or around 4 November 2020.

#### 3. Ministerial Direction: Wet Pubs Business Support Scheme

The Committee noted correspondence dated 4 May 2021, from Mr Kieran Donnelly, C&AG regarding a Ministerial Direction on 'Wet Pubs Business Support Scheme'. The Permanent Secretary, Mr Mike Brennan wrote to the C&AG on 20 April 2021 to advise that he had sought a ministerial direction from the DfE Minister, Diane Dodds MLA, on 11 December 2020 to implement a Wet Pubs Business Support Scheme (WPBSS).

The Committee noted the delay in the Department notifying the details of the Ministerial Direction to the C&AG and hence the delay in this correspondence to the Committee.

**Agreed:** The Committee noted the Ministerial Direction and the relevant papers underpinning the decisions.

**Agreed:** The Committee noted the C&AG will keep this matter under review as the Audit of the 2020-21 financial statements progresses; and that the C&AG is currently in discussion with the Department on what caused the delay and what actions they have taken to ensure this will not happen again.
