The meeting commenced in Closed Session at 2.04

The Committee considered correspondence dated 6 May 2021 from Mr Russell Smyth, Partner KPMG regarding the evidence session of 22 April 2021 on Generating Electricity from Renewable Energy and the availability of Professor Hughes' submission 'Small Wind Generation in Northern Ireland' prior to their evidence session.

Agreed: The Committee agreed to write to Mr Smyth to clearly outline privilege: 'that Under Section 50 of the Northern Ireland Action 1998 for the purposes of the law of defamation, absolute privilege applies to statements made to or in the report of a committee of the Assembly. This privilege covers all evidence given by a witness to a committee whether in oral or in written form. It means that no action may lie in defamation against a witness in respect of such statements.'

Agreed: The Committee noted the additional information in Mr Smyth's correspondence regarding the inquiry and agreed to invite Mr Smyth to forward any further relevant information regarding the inquiry.

Agreed: The Committee agreed to hear further evidence from KPMG, if felt relevant.

The Committee noted correspondence dated 6 May 2021 from Sue Gray, 6 May 2021 regarding recruitment to key commercial and procurement roles. Memo from Audit Committee - Report on Estimates

The Committee noted a Memo from the Audit Committee date 11 May 2021, regarding the 'Report on Estimates of the Northern Ireland Audit Office and the Northern Ireland Public Services Ombudsman 2021 – 22' NIA 95/17-22.

Agreed: The Committee noted the Audit Committee will forward the estimates to the Department of Finance for inclusion within the Main Estimates 2021-22.

Localised Restrictions Support Scheme – Overpayments

The Committee noted correspondence from Ms Sue Gray dated 13 May 2021 regarding Localised Restrictions Support Scheme – Overpayments. This was a follow up from Ms Gray's correspondence of 13 April 2021 including a table with details of current overpayments, and at **Annex A** a breakdown of 51 businesses who were not eligible.

The Committee noted that the total value of all payments issued in error, still to be recovered, is £5,220,568. This is 1.7% of the overall value of all payments issued through the LRSS to date (£306,505,730).



Agreed: The Committee noted the correspondence and that Ms Gray will continue to keep the Committee updated.
