Officials agreed to provide to the Committee: a summary of the infraction risks and ongoing cases, breaking down those that apply to the UK and to Northern Ireland only; written information on (i) a breakdown of the resource and capital budget for the Group, (ii) the budget for the functions which were not part of DARD in the last financial year and (iii) the current budget; details on how close the oil drilling at Woodburn Forest is to the ASSI; details on the monies collected and its distribution under the Aggregate Credit Levy Scheme; a written update on the outcome of the Dilapidated and Neglected Sites and Marine Conservation Zone consultations; the Departmental position, and the position elsewhere, on Japanese knotweed and hogweed; and the Departmental position on the proper disposal of the plastic waste on hay bales on farms.

Officials agreed to provide to the Committee: the budget for the RDP and its split by EU and national monies and how much of this crosses over into Growing for Growth; information on those participating in qualifications for the Young Farmers Payment Scheme, including the number of those that moved onto Level 3; update on what informal procedures are used before a case enters the formal Review of Decisions Appeal system; the process for the Review of Decisions and the number of successful and unsuccessful applicants at each stage; confirmation of whether the Department makes publically available a list of Agents who will complete the SAF for farmers; whether staged payments will be possible under the LEADER element of the 2014-2020 RDP; updates on the Department's plans on achieving 100% communication with farmers online; and a written update from the Agri-food Strategy Board on the work it has done on fairness in the food supply chain.
