8. Departmental Written Briefing: SL1 – The Agricultural Commodities (Coronavirus) (Income Support) Scheme No.2 (Northern Ireland) 2021

The Committee considered SL1: The Agricultural Commodities (Coronavirus) (Income Support) Scheme No.2 (Northern Ireland) 2021 which will allow the Department to make Covid-19 income support payments of up to £5.2m to pig producers in respect of cull sows, sheep producers in respect of wool, and potato producers directly affected by the COVID-19 pandemic impact on the agri-food industry.

Agreed: The Committee agreed to write to the Department to request a timescale for the issue of payments for the compensation scheme.

Agreed: The Committee agreed to write to the Department to seek clarification on who is required to complete the sheep inventory and whether the information gathered will be held centrally within the Department upon completion.
