2 Minutes of previous meetings

2.1 The minutes of the meeting on 6 October were **agreed**.

3 Matters Arising

3.1 Members **noted** that the Committee on Procedures had written seeking views on the temporary provisions provided for by SOs 110 -116, so that it can consider any potential amendments.

3.2 Members **noted** that they had agreed to consult with their parties and bring views to the Committee in time to respond to the Committee on Procedures by the deadline of 23 October.

3.3 Members **agreed** to bring any views to the Committee at the next meeting.

3.4 There were no other matters arising.

4 Finalisation of the Order Papers for the Plenary Meetings on Week Commencing 19 October 2020

Monday 19 October

Assembly Business

4.1 Members **noted** that the UUP was seeking to schedule a Committee membership motion on this date.

4.2 Members **agreed** to schedule the motion as a business motion with no debate or amendment.

4.3 Members **noted** that Question Time was scheduled for the Education and Finance Ministers.

4.4 Members **noted** that they had previously agreed a single debate for the Supply Resolution for the Main Estimates 2020-21, and Supply Resolution 2016-2017 Statement of Excesses.

4.5 Members **noted** that the Minister of Finance intended to introduce the Budget (No. 3) Bill after the supply resolution debates.

- 4.6 Members **noted** that Executive Office has now scheduled three additional items of business for the Minister for Communities for which they have requested a single debate, as follows:
- The Health Protection (Coronavirus, Restrictions) (No. 2)(Amendment No. 5) Regulations
 - The Health Protection (Coronavirus, Restrictions) (No. 2)(Amendment No. 6) Regulations
 - The Health Protection (Coronavirus, Restrictions) (No. 2)(Amendment No. 7) Regulations
- 4.7 Members **agreed** to schedule a single untimed debate to consider all three motions to approve the statutory rules.
- 4.8 Members **noted** that the Minister of Finance had tabled a motion seeking to suspend Standing Orders 10(2) to 10(4), which would allow the sitting to extend beyond 7pm should it be necessary, and that it had been scheduled as the first item of Executive Business.
- 4.9 Members **noted** that the Minister for Communities also intended to introduce the Licensing and Registration of Club (Amendment) Bill but that this would not be included on the indicative timings until the Speaker was content the Bill was within the legislative competence of the Assembly.
