The Executive Office

- 1 **Apologies**
- 1.1 Apologies were received from Robbie Butler.
- 2 Minutes of previous meeting
- 2.1 The minutes of the meeting on 8 June were **agreed**.

# 3 **Matters Arising**

- 3.1 Members **noted** that following the very late sitting on 8 June, the Speaker had written to all Ministers regarding the need for efficient scheduling of Executive Business, and that a copy of this letter had been provided in Members' papers.
- 3.2 There were no other matters arising.

#### 4 Consent Decisions

- 4.1 Members **noted** that at the meeting on 1 June, they had considered correspondence from the Committee on Procedures seeking the views of the Business Committee on provision for handling consent decisions and had agreed to consider and return to discuss a response.
- 4.2 Members **noted** that an advice paper had been circulated to inform their consideration of the issue.
- 4.3 Following discussion, Members sought further information and **agreed** to consider the issue and discuss again at the next meeting.

# 5 <u>Finalisation of the Order Papers for the Plenary Meetings in Week</u> <u>Commencing 21 June 2021</u>

#### Monday 21 June

#### **Assembly Business**

- 5.1 Members **noted** that the resignation of Mrs Arlene Foster as First Minister resulted in vacancies in both the Office of the First Minister and the deputy First Minister.
- 5.2 Members **noted** that section 16B of the 1998 Act sets out the requirements for filling vacancies in these offices and there is a statutory requirement for them to be filled within a period of seven days, i.e. by 1pm next Monday.
- 5.3 On that basis Members **agreed** to schedule an item of business for filling the vacancies in the offices of First Minister and deputy First Minister on the Order Paper for Monday 21 June.
- 5.4 Members **agreed**, in the event that nominations to the posts are made, to limit the total time for comments by other Members to 30 minutes with each Member having no longer than 3 minutes.

- 5.5 Members **agreed** that if the posts were not filled, there would be no opportunity for comment by Members.
- 5.6 Members **agreed** to schedule a Committee Membership motion for the DUP, subject to the final wording being provided later that day.

- 5.7 Members **noted** that, in addition to the business agreed at last week's meeting, the Executive Office had listed a further three items of business.
- 5.8 Members **noted** that the First Stage of the Charities Bill had been scheduled, and would be added to Indicative Timings when legislative competence had been confirmed.
- 5.9 Members **agreed** to schedule an untimed debate to approve the draft Administration (Restrictions on Disposal etc. to Connected Persons) Regulations (Northern Ireland) 2021.
- 5.10 Members **agreed** to schedule an untimed debate for the motion to approve the Employment Rights (Northern Ireland) Order 1996 (Protection from Detriment in Health and Safety Cases) (Amendment) Order (Northern Ireland) 2021.
